Sir,

I, **SMT. ANJALI SINGH**, Wife of Fatik Singh & D/o. Late. Manmohan Barman, Hindu by religion, Business by occupation, Indian by Nationality, residence of Naguru Jote, P.O. Nimai, P.S. Matigara, Dist. Darjeeling, Pin Code- 734010, West Bengal.

I would like to request you to lodge FIR against some miscreants & land mafias whose names are (1) **Smt. Balika Devi Chowdhury**, W/o. Rajmal Chowdhury, (2) **Sri. Sanatan Chowdhury** S/o. Rajmal Chowdhury, (3) **Smt. Mamta Chowdhury**, D/o. Rajmal Chowdhury, (4) **Sri. Ajoy Barman**, one of the son-in-law of Smt. Balika Devi Chowdhury, all are the residents of Vill - Goyal Jote, P.O. Nimai, P.S. Matigara, Darjeeling, for stealing of my 500 nos. (approx.) stored bricks, for intentionally damaging my house & property, forcefully damaging & demolishing of boundary foundation and wall, for attacking on me & causing injury to my men and life threatening with sharp weapons and lathis.

Whereas I am the absolute recorded owner in possession of a piece or parcel of land measuring 01 Katha, in R.S. Plot No. 29 corresponding to L.R. Plot No. 31, in L.R. Khatian No. 1584, within the Mouza: Nimai, J.L. No. 57, Pargana Patharghata, under Police Station Matigara, Dist. Darjeeling by virtue of inheritance having permanent, heritable and transferable right, title and interest therein, free from all encumbrances and charges whatsoever. And whereas I am the owner in possession of a piece of PWD possession land measuring 3 Katha, in L.R. Plot no. 31 & R.S. Plot No. 29, at Mouza- Nemai, J.L. No. 57, situated at vill- Goyal Jote, under Patharghata G.P, P.S. Matigara, Dist. Darjeeling which is situated at the front side of the Pankhabari Mirik Road. Accordingly I am the absolute recorded owner in possession of total land measuring 04 Katha (01 Katha & 03 Katha) which is bounded by boundary wall. And for such I have constructed 01 nos. house, stored a good numbers of bricks & other materials on it and have constructed boundary surrounded to it.

AND one of the said miscreant/ land mafia Smt. Balika Devi Chowdhury has purchased a piece or parcel of land property measuring 10 Katha (16.50 Decimal) from my father Sri. Manmohan Barman, in R.S Plot No. 29 corresponding to L.R. Plot No. 31, within the Mouza Nimai, J.L. No. 57, Pargana Patharghata, under Police Station Matigara, Dist. Darjeeling and after such she has recorded the said land in her L.R. Khatian No. 1753, which is adjacent to my land property which is mentioned above properly and is situated on the backside i.e on the west side of my land property.

That on 24.11.2022, in the afternoon, I came to know that my said land properties has been damaged by the said miscreants Smt. Balika Devi Chowdhury, her children Sri. Sanatan Chowdhury & Smt. Mamta Chowdhury along with her son-in-law Sri. Ajay Barman. And after getting the information I along with my men have reached on my said land and very politely I have requested the said land mafias to stop their illegal work of encroachment and hooliganism. But, these said land mafias attacked and started beating my men somehow my men managed to escape. These said land mafias have refused my request on my face by delivering slang & faulty languages and have threatened to kill me & my men if we try to stop them from doing their illegal works. They ordered me to leave the said land property immediately else has to face fatal consequences. And these land mafias forced my men to remove all of my stored construction materials from there and attempted to demolish my house build on my said land and they have also damaged my foundation of boundary wall in west and north side. And I found that more than 1500 nos. of my stored bricks are missing from my land and for such I strongly believe they have stolen the stored bricks in my absence and sold to other persons for money without my consent. At that heat fearful situation I had to leave the spot with my men to save our lives.

And I would like to make it clear that the land measuring 10 Katha of Smt. Balika Devi Chowdhury is lying after my purchased land property i.e on the west side and there is no connection between my above mentioned recorded land measuring 01 Katha with her purchased land measuring 10 Katha. And I would like to declare that no part or any portion of land of Balika Devi Chowdhury has ever been captured or encroached by me or by any of my men till date. She is living on her claimed land measuring 10 Katha at her own house only without any interferences & disturbances from my side.

That Smt. Balika Devi Chowdhury & her relatives have conspired many times to grab my said recorded land. And, I am very astonished and shocked that how these ill minded land mafias got so much courage to capture other's recorded land.
