I, Aftab Alam son of Mohammed Zahoor, resident of 10/1B, Bright Street, PS- Karaya Kolkata - 700 019 and Permanent resident of Chitbara Goan Dist - Balia UP one of the legal heirs of Mohammed Zahoor would like to draw your kind notice to the fact that:-

That my father Mohammed Zahoor son of Sekh Fathey Mohammed is/was the absolute recorded tenant/owner with respect to the lands measuring about 56 decimal (out of total land 1.03 acres) recorded in R.S. Khatian No. 8/11 corresponding to L.R. Khatian No. 27, R.S. Plot No. 39 Corresponding to L.R Plot No. 596, of Mouza Panchkulguri J.L No. 59, under Police Station Matigara, District Darjeeling -

That recently I came to know that some People namely (1) Mohammed Md. Zahid son of Nazir Hussion, resident of Khaprial, Jali Busty, P.O. New Chamta P.S. Matigara, Dist - Darjeeling, in collusion with (2) Sankar Prasad Sharma (Aovocate, Siliguri) (3), Indu Chhetri wife of Bishal Chhetri resident of Ghumti Goan, Lebong, Dist- Darjeeling (4) Pradip Biswas (Amin) of Siliguri, (5) Md. Jalaluddin Ansari son of Abdul Sattar and (6) Rakib Ansari son of Md. Jalaluddin Ansari both are resident of Khopalasi, Post Office New Chamta, Police Station Matigara, Dist- Darjeeling with malafide intention, fraudulently / dishonestly making fake recorded owner

namely Manjila Khatun @ Manjila Begam wife of Md. Zagir of Panchkulguri, P.O. Nema P.S. Matigara, Dist- Darjeeling, of my aforesaid land measuring 7 Katha or 11.56 decimal (out of 56 decimal), and the above said accused persons recorded the said land illegally by way of Criminal Conspiracy with the than Revenue/Block Land and land reforms Officer along with other official staff, Shivmandir, Matigara Block, Dist- Darjeeling, in spite of the knowledge that the said land measuring 7 Katha or 11.56 decimal is/was recorded in the name of my father Mohammed Zahoor son of Sekh Fathey Mohammed and with said forged/fake record, manufacturing documents, illegally have sold out my/our recorded land measuring 3 Katha (out of my total recorded land measuring acres) to one Sri Bishal Chhetri son of Kul Bahadur Chhetri (Pan No. AGEPC4275F) being Deed No. 3954 dated 26/07/2022 of Chiriya Kothi, Middle Harsing Hatta, P.O. Leborg P.S. & Dist- Darjeeling and said (1), (2) Sankar Prasad Sharma (Aovocate, Siliguri) (3), Indu Chhetri wife of Bishal Chhetri resident of Ghumti Goan, Leborg, Dist- Darjeeling (4) Pradip Biswas (Amin) (5) Md. Jalaluddin Ansari son of Abdul Sattar and (6) Rakib Ansari son of Md. Jalaluddin Ansari and Sri Bishal Chhetri son of Kul Bahadur Chhetri have fraudulently cheated me/us

and of my /our lawful right, title and interest over the said land.

Under the above facts and circumstances it is prayed before your honour that your honour will be pleased to investigate the above matter and further be pleased to take appropriate legal action under the provision of Law against the above named accused persons and prays for proper Justice.
