Subject: Written Complaint

Respected Sir,

I, Gita Sharma, aged 37 years, wife of Anirban Chakraborty, resident of Sarda Sky Rise Apartment, Opposite to Pintel Village, Dagapur, P.O. & P.S. Pradhan Nagar, District - Darjeeling would like to inform you that that there are a number of civil and criminal cases pending litigation between me and my husband within the jurisdiction of Siliguri Court and in order to apply pressure upon me to withdraw all the pending cases my husband in conspiracy with below-mentioned residents of my apartment namely Jayita Mukherjee, Krishna Mukherjee, Amit Hussain, Shyam Tamang and his wife, Makar Limbu, Bipul Chandra Gharami, Rupali Gharami, Goutam Chakraborty and Deepa Chakraborty have been consistently torturing me, my minor son and my breast sucking daughter by their violent and inhuman actions and for which they randomly arrive at my doors and abuse us in loud and hurling voices using all kinds of filthy languages, hitting me and my children and passing indecent comments on us and are also threatening us with dire consequences that they will not hesitate in taking my and mine children life away and because of which me and my minor children are wrongfully confined in our own house.

On 14.12.2022 at about 9:45 am when I along with my minor children was going to Siliguri Court, near Tata Motors at Pintell village suddenly Jayati Mukherjee who driving her scooty came rashly towards me in full speed and hit me hardly for which I fell down and received grave injuries over my body and thereafter she kicked me and laughed over me and thereafter with the help of local people I was taken to Siliguri District Hospital for the treatment but to my extreme shock and surprise she lodged a false case against me vide Pradhan

Nagar P.S. Case No. 1038/2022 dated 14.12.2022 u/s 341 and 323 IPC.

It is pertinent to mention here that even on previous occasions to put pressure upon me to withdraw all my cases against my husband all the above-mentioned persons conspired against me and implicated me in a false case vide Pradhan Nagar P.S. Case No. 233 of 2022 dated 30.03.2022 u/s 341/307 IPC and Pradhan Nagar Case No. 154/2022 dated 23.02.2022 u/s 341/323 IPC.

That the aforesaid persons have warned me that in case I try to intimate or report the above matter to any other person or seek any help of the law enforcement agencies, then they will go to any extent for ruining our life and liberty

I am a helpless lady who has been made victim of my husband's conspiracy with above-mentioned persons and my and my children's life is in extreme risk and danger and which has adversely affected our health condition.


It is my humble and sincere request to you to look into this matter at the earliest in order to save life and liberty of mine and my minor children from the tricks and tantrums of all the above-mentioned persons and to take immediate and necessary actions against them and charge them under relevant laws of the land.
