I, MeherunNisa, wife of Md. Budhan Qureshi, resident of Dangipara, Rail Line, Ward No. 6, P.S. Siliguri, would like to lodge a complaint against 1. **Ruby Khatoon**, wife of Rehemat Qureshi, Kholabaktari, P.S. Matigara 2. **NaseemaKhatoon**, wife of Lt. Moti Qureshi, Qureshi Mohalla, P.S. Siliguri 3. **SabanaKhatoon**, wife of Dablu Qureshi, Qureshi Mohalla, P.S. Siliguri 4. **Sitare Qureshi**, son of Kaiser Qureshi, Qureshi Mohalla, P.S. Siliguri 5. **Aman Qureshi**, Son of Kaiser Qureshi, Qureshi Mohalla, P.S. Siliguri 6. **BegamKhatoon**, wife of Kaiser Qureshi, Qureshi Mohalla, P.S. Siliguri, 7. **Dablu Qureshi**, son of Lt. Moti Qureshi, Qureshi Mohalla, P.S. Siliguri and 8. **Kaiser Qureshi**, son of Lt. Moti Qureshi, Qureshi Mohalla, P.S. Siliguri

That at around 9:30-10:45 today, my grandson Samir Qureshi had gone to meet his mother, Ruby Khatoon at her(Ruby) in-law's house at Qureshi Mohalla. Ruby Khatoon along with NaseemaKhatoon, SabanaKhatoon, Sitare Qureshi, Aman Qureshi, BeghamKhatoon, Dablu Qureshi and Kaiser Qureshi started beating my grandson Samir Qureshi. They beat up my grandson black and blue with an intent to kill him with thick bottom wood. He was beaten up so bad that due to internal injury he was coughing blood and his face is all swollen up and now he is admitted at Siliguri District Hospital.

My son Mehboob Alam (uncle of Samir Qureshi), happened to be in the same neighbourhood and when he saw Ruby Khatoon and others beating up Samir

Qureshi, he took a video and proof such incident has been recorded. While he was taking such video, they beat up my son Mehboob Alam also with thick bottom wood and due to which he suffered a cut on his head got two stitches and swellings on head.

They continued beating up my grandson Samir Qureshi and he fell unconscious. And now he is currently admitted at Siliguri District Hospital with Severe pain and injury.

Mehboob Alam, somehow managed call me and I along with Aklima Khatoon (my daughter) went to the spot. We reached at the spot to rescue Mehboob Alam and Samir Kureshi, then the above mentioned persons pulled my hair from back and snatched my gold chain from the neck

I would like to request you to kindly take necessary actions against the above named Ruby Khatoon, Naseema Khatoon, Sabana Khatoon, Sitare Qureshi, Aman Qureshi, Begham Khatoon, Dablu Qureshi and Kaiser Qureshi at the earliest.
