Darjeeling, would like to inform you that one RATAN SARKAR, son of Unknown, residing at the above mentioned address, is my neighbour who often creates ruckus and conflicts in petty matters with me and my family. That on 15.12.2022 at about 10:00, in spite of several requests for trimming the branches of a Mango Tree of said Ratan Sarkar which is dangerously tilted towards our Tin-shed house, my son cut-down the branches and on a response said RATAN SARKAR physically assaulted me on my persons and also used slang and filthy languages against me and my daughter-in-law. He also threatened us that he will beat all of us to death within short time.

Read over and explained to me in Bengali language by Adv. Konstar Chatterjee

I therefore, request you kindly take necessary legal steps against said RATAN SARKAR. I shall be highly obliged to you.
