Respected Sir,

With due respect I, Ratan Sarkar, S/O - Late Manoranjan Sarkar, Resident of Kawakhali, P.O - Sushrutnagar, P.S - Matigara, Dist - Darjeeling, beg to inform you that I along with my family reside at Kawakhali since long and we are peace loving people of that locality and the house of Ashu Sarkar situated on the southern side of my house.

It is pertinent to mention here that there is a Mango tree (age near about 6/7 years) in my house in side the boundary wall on south side but without my permission and in our absence when we were outside on 14/12/22 said Ashu Sarkar has cut the several branches of my said Mango tree and at night after returning home, I found that several branches are cut down badly as it is very difficult for the tree to survive further and on asking, my minor daughter said that even after her protest said Ashu Sarkar has forcefully cut the branches of the said tree and they uses filthy languages towards her.

It is to be noted here that today morning when I saw the mother of Ashu Sarkar at that time I gently asked her why they cut the branches of the tree in my absence and if there is was/is any problem I would have cut the branches if they told me but the mother of Ashu sarkar did not say anything to me and remain silent and after that she went her home.

It is very unfortunate that after a while, today on 15/12/22 near about 10.00 am when I was inside the house and my wife and my minor daughter were in my shop, all the family members of Ashu Sarkar (namely 1. Ashu Sarkar, S/O - Late Garsi Ram sarkar, 2. Smt. Lalita Sarkar, W/O - Ashu Sarkar, 3. Smt. Sumati Sarkar, W/O - Late Garsi Ram sarkar all are resident of Kawakhali) came in-front of my shop and started to use filthy languages towards me and my family members and when my wife and my minor daughter protested them at that time they all on a sudden attacked upon my daughter and mercilessly beaten my daughter and slapped my daughter and they all threatened my daughter as well as my family members with a dire consequences to ruin our lives by some faul means and they also threatened us that they will implicate us in some false cases.

It is therefore prayed that I am in great fear and anxiety for the activities of the above named persons and cordially requesting you to take legal actions against all the above named persons for their illegal activities to save our life as well as our property for ends of justice.
