Dear Sir,

I, Ashoke Kumar Ghoshai, son of Late Bijoy
Krishna Ghoshai, resident of Vill & PO - Khanyadihi,
Purba Midnapur, West Bengal, 721641, hereby inform you
that my nephew Biswajit Ghoshai, son of Sri Haripada Ghoshai,
has been hit and severely injured yesterday i.e. 09/12/2022 at
about 3:45 pm (approx.) while he was travelling on his
bike from Gajoldoba to Siliguri. I was informed by local
persons who are also the eye witnesses, that a Mahindra
Scorpio (Vehicle Reg. No. WB 74 BB 1948) was moving at high
speed in a very reckless manner towards Gajoldoba when
it tried to overtake a dumper truck and hit my nephew
Biswajit directly head on who was travelling from the
opposite direction in his bike (Vehicle Reg. No. WB 74 BC 4619).
The severity of the collision was so much that Biswajit
was thrown about 30 ft away from the road as a result
of the impact of the collision. The offending vehicle
bearing Reg No. WB 74 BB 1948 tried to flee from the spot
but somehow fell down by the side of the road as a result
has been handed over to the Police authorities by the
local people. Place of occurrence is near Simulgarai.
