Sir,

With due respect, I am producing herewith one arrested accused person namely Md. Babul (24) s/o Sabrata of Chorigodi, PO- Harinmari, PS- Baliadangi, Dist.- Thakurgoan, Bangladesh under arrest. The ground of arrest duly been communicated with him.

I, PSI-Sonu Chik Baraik presently attached with NJP PS under your kind control beg to state that today i.e. on 10.12.2022 at 20.25 hrs I received a secret source information that One person of Bangladesh National is roaming around Badlagach, Border area near Fulbari under NJP PS illegally without valid Passport/Visa. Accordingly, I Informed the fact to SI-Partha Sarathi Das, Officer-In-Charge, New Jalpaiguri PS, Siliguri Police Commissionerate as well as Assisstant Commissioner of Police, East-II, Siliguri Police Commissionerate and diriez the fact vide New Jalpaiguri PS GDE No.- 460 date: 10.12.2022. As per your kind order, myself along with ASI-Sajal Das, IIG/794- Ranjit Roy, VP/13- Jamirul Islam, CV/116 Rohit Kumar Mahato, VP/08 Laxman Roy all are of New Jalpaiguri PS, Siliguri Police Commissionerate left for Badlagach, Boarder area, near Fulbari, under New Jalpaiguri PS, Dist.- Jalpaiguri to verify the verisity of the information. At about 20.55 hrs we arrived at Badlagch, Boarder area at Fulbari, under New Jalpaiguri PS, Dist.- Jalpaiguri and found that one person is roaming around Badlagach, Fulbari Boarder area in suspicious manner. Accordingly as per the indication of source, we apprehended the person and on being asked he gave different statement in different time. After prolonged interrogation, he disclosed his name and address as Md. Babul (24) s/o Sabrata of Chorigodi, PO- Harinmari, PS- Baliadangi, Dist.- Thakurgoan, Bangladesh. On further interrogation, he admit his guilt and state that he illegally entered into India. On further interrogation, on being asked, he failed to produce any valid documents/Passport/Visa in support of residing in India or entery into Inida. Accordingly, I, arrested the accused person namely, Md. Babul (24) s/o Sabrata of Chorigodi, PO- Harinmari, PS- Baliadangi, Dist.- Thakurgoan, Bangladesh after issuing proper Memo of Arrest and observing all the guidline issued by the Apex Court for violating the Foreigner Act.

Under this fact and circumstances it is establish that the above noted accused person entered into India by means of Illegal which is restricted for their country with supporting documentary permission from the concern Authority, notified by the central Government. In Governemnt Official Gazattee as well as stay in any area without valid required for such entry or for such stay.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Md. Babul (24) s/o Sabrata of Chorigodi, PO- Harinmari, PS- Baliadangi, Dist.- Thakurgoan, Bangladesh and arrange for its investigation.
