Sir,

With due respect and humble submission, I SI Ajay Pradhan of NJP Police Station under Siliguri Police Commissionerate do hereby lodged a written complaint against 1) Smt. Sikha Chatterjee, M. L. A. Dabgram Fulbari, 2) Anjali Mahanta, 3) Ram Chanra Jaysawal, 4) Puja Debi, 5) Sita Debi, 6) Raso Debi, 7) Lalsa Debi, 8) Mayna Chowdhury, 9) Suchitra Roy Sl. No. 2 to 8 are Adhikary Pally, PS NJP, Dist. Jalpaiguri, and 25/30 others to the effect that on 12.12.2022 at 07.55 hrs. I along with force had been detailed to perform mobile duty vide mcc No. 1760/22 dated 12.12.2022 at 07.55 hrs. In course of my mobile van duty, I received an information from duty officer that local people of Adhikar pally started a road blockade on Eastern by pass Road, near Sahudangi Samsan Ghat over the issue of illegal construction of River Jhora in that area.

Therefore, we reached the spot at 09.45 hrs. And found that around 30/35 persons had assembled there under the leadership of the above noted persons as well as Smt. Sikha Chatterjee, M. L. A. Dabgram Fulbari who had blocked on Eastern by pass Road, near Sahudangi Samsan Ghat with an intention to mischief by injury to public roads and were raising slogans for their demand. The blocked had stopped the free flow traffic, causing traffic jams which caused harassment to the public in general. Police team requested those several times to withdraw the road block but picketers did not pay any heed. The block was continuing for more or less 35 minutes.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the above noted accused persons namely 1) Smt. Sikha Chatterjee, M. L. A. Dabgram Fulbari, 2) Anjali Mahanta, 3) Ram Chanra Jaysawal, 4) Puja Debi, 5) Sita Debi, 6) Raso Debi, 7) Lalsa Debi, 8) Mayna Chowdhury, 9) Suchitra Roy Sl. No. 2 to 8 are Adhikary Pally, PS NJP, Dist. Jalpaiguri, and 25/30 others and arrange for its investigation
