In producing herewith following articles under proper seizure list-

- 1] 10 (Ten) bottles of Tuborg Strong beer (each bottle containing 650 ml)
- 2] 06 (Six) bottles of EM-boss Fine Whisky (each bottle containing 750 ml)

I, SI Rantu Haldar of Bhaktinagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one namely 1.Samiran Bhujel (37 Years) s/o- Shiba Bhujel of Bhalukop, Samsing, P.S-Jhalung, Dist-Darjeeling, A/P-Milon More, Debidanga, P.S-Pradhannagar, Dist-Darjeeling to the effect that today on 14/12/2022 at 14.25 hrs while performing evening patrolling duty, received a source information that one person namely Samiran Bhujel (37 Years) is selling liquor in a corner of Gandhi Maidan under Bhaktinagar PS, without any valid license. Accordingly I informed the matter to the I/C PS and as per his kind direction myself along with force- C/1431 Dilip Barman, CVF /-935 Biplab Roy had been to Gandhi Maidan under Bhaktinagar PS to verify the veracity of the information. On reaching there and as identified by the source I along with my force cordoned the area. But seeing us the above noted accused person could manage to flee away from the spot. I held raid thorough search in that area in course of which I recovered the above noted bottles of liquors inside of his shop. I searched for its claimant but nobody came forward and produced any valid document in support of those bottles of liquors. I also examined several local people from whom identity of the owner of the said shop ascertained as mentioned above and also learnt that the above noted bottles of liquors were procured and stored by the above noted accused person illegally and who used to sell it to the local youths since last 03 (Three) months for his illegal gain. Accordingly, I seized the above noted bottles of liquors as alamats under proper seizure list .The search and seizure was made in between 15.15 hrs. to 15.35 hrs.


I, therefore pray before your good self that a specific case may kindly be initiated against 1.Samiran Bhujel (37 Years) s/o- Shiba Bhujel of Bhalukop, Samsing, P.S-Jhalung, Dist-Darjeeling, A/P-Milon More, Debidanga, P.S-Pradhannagar, Dist-Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
