Sir,

In producing herewith one accused person namely 1.Swapan Roy (42 years) S/O- Amal Krishna Roy of Bherbheri, P.S-Chopra, Dist-Uttar Dinajpur A/P-Mamu More, W/N-41, P.S- Bhaktinagar, Dist- Jalpaiguri along with following articles under proper seizure list-

- 1) 12 (Twelve) bottles of Sterling Reserve Whisky (each bottle containing 750 ml)
- 2) 06 (Six) bottles of Himalayan Gold 60 UP Country spirit (each bottle containing 600 ml)

I, PSI Chiranjit Saha of Bhaktinagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one namely 1.Swapan Roy (42 years) to the effect that today on 15/12/2022 at 18.05 hrs while performing evening patrolling duty, received a source information that one person is selling liquor near Don Bosco More under Bhaktinagar PS, without any valid license. Accordingly I informed the matter to the I/C of PS and as per his kind direction myself along with force-C/1431 Dilip Barman, CVF /-935 Biplab Roy, CVF/- 014 Lanbanyamoy Barman had been to Don Bosco More under Bhaktinagar PS to verify the veracity of the information. On reaching there and as identified by the source it found that one person was selling near Don Bosco More under Bhaktinagar PS. Subsequently, I along with my force cordoned the place and was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above. Further being searched the above noted seized articles were found from his possession. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further he stated that he is involved in selling and possessing of liquor without any valid license for last 03(Three) months for his illegal gain. Then I seized the above mentioned liquor under proper seizure list in presence of independent witnesses and arrested the above mentioned person namely 1.Swapan Roy (42 years) S/O- Amal Krishna Roy of Bherbheri, P.S-Chopra, Dist-Uttar Dinajpur A/P-Mamu More, W/N-41, P.S- Bhaktinagar, Dist- Jalpaiguri after observing all sorts of formalities at the spot. The whole process of seizure has been made in between 18.55 hrs to 19.15 hrs at the spot. As he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person u/s 41 Cr.P.C appraising him the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against 1.Swapan Roy (42 years) S/O- Amal Krishna Roy of Bherbheri, P.S-Chopra, Dist-Uttar Dinajpur A/P-Mamu More, W/N-41, P.S- Bhaktinagar, Dist- Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
