Sir,

With due respect and humble submission, I ASI Tanmoy Roy, presently posted at Bhaktinagar Police Station, Siliguri Police Commissionerate beg to report that, on 15.12.2022 at about 17:10 hrs during my evening RT mobile van duty, received an information from PS on duty officer that, today i.e on 15.12.2022 at about 16.50 hrs a labour has fallen from the height in a construction cite, located at Pronami Mandir road under Bhaktinagar PS. Accordingly, I along with my accompanied force had been to Pronami Mandir Road near ASG Eye Hospital and found that it was G+7 under construction cite where labours were engaged for painting work of the said building but winch in which the labours was standing for paint purpose couldn't bear the weight of labours due to rusting they fall down. I came to know that, out of 02 labours 01 person succumbed to the injury on the spot and another labour has been shifted to Ananda Loke Hospital, Sevoke Road in critical condition for his treatment where he was admitted in the Hospital. The complainant further came to learnt that the name of the deceased labour is Samiruddin Shekh, age-33 years (approx), C/O- Shamshad Shekh of Ghola, Doltalaghola, PS- Baruipur, Dist- South 24 Parganas whose body has been sent to Siliguri District Hospital for autopsy.


During preliminary enquiry, I came to learnt that, this accident happened due to negligent act of builder(s) and labour contractor of the said building.

Hence, I pray before you that, necessary order may kindly be accorded for its investigation and legal action against the builder(s) and labour contractor of the said building.
