Sir,

In producing herewith the following accused namely (1) Himu Jha (24) S/O Monoj Jha Of Sastri Nagar W/No 41, PS Bhaktinagar, Dist Jalpaiguri (2) Bijoy Patwari (27) S/O Adhir Patwari Of Bottle Company, Amtala, PS Bhaktinagar, Dist Jalpaiguri (3) Bicky Roy (20) S/O Kailash Roy Of Ektiasal, Near Hari Mandir, PS Bhaktinagar Dist Jalpaiguri (4) Bhubesh Shil (22) S/O Sushil Shil Of Bottel Company, Near Banshjar, PS Bhaktinagar Dist Jalpaiguri in custody along with the following seized articles:-

- i. One Khukri measuring about 11 inches in length made of iron including its wooden butt was recovered from the possession of accused Himu Jha (24) S/O Monoj Jha of Sastri Nagar W/No 41, PS Bhaktinagar Dist Jalpaiguri
- ii. One (1) Knife measuring about 11 inches in length made of iron including its wooden butt was recovered from the possession of accused Bijoy Patwari (27) S/O Adhir Patwari Of Bottle Company, Amtala, PS Bhaktinagar, Dist Jalpaiguri.
- iii. One (1) house breaking implement made of iron with pointed end measuring about 21" in length was recovered from the possession of accused Bicky Roy (20) S/O Kailash Roy Of Ektiasal, Near Hari Mandir, PS Bhaktinagar Dist Jalpaiguri.
- iv. One(1) iron rod measuring about 3 feet in length was recovered from the possession of accused Bhubesh Shil (22) S/O Sushil Shil Of Bottel Company, Near Banshjar, PS Bhaktinagar Dist Jalpaiguri.

I, S.I Pradip Kr Singha of Ashighar OP P.S Bhaktinager would like to lodge this written complaint against the above noted accused persons and also 10/11 other unidentified persons to the effect that today i.e. on 16.12.2022 at about 00.05 hours received a secret source information that a group of 14-15 persons have assembled at Fakdaibari Necha busy ground Near Dabgram-II Beat office, under Bhaktinager P.S, Dist Jalpaiguri with deadly weapons with a view to commit some heinous crime. Accordingly without wasting any time I informed the matter to O/C Ashighar OP and diarised the whole fact in Ashighar OP GDE No. 359 dated 16.12.2022, Then at 00.15 hrs, as per instruction of O.C Ashighar OP I along with ASI Krishna Ch Singha, ASI Amit Mallick C/970 Bikash Roy, C/ 134 Ginen Basumata, CV/909 Nityananda Choudhury all of Ashighar OP left for spot to verify the veracity of the information and to work upon it, noted in Ashighar OP GDE NO. 360 Dt- 16.12.2022. We reached near the spot as directed by the source at about 00.35 hours and stopped at a considerable distance from above noted spot and we started walking towards the P.O with due care so that no one could anticipate our movement. On way we meet two respectable persons of the locality namely (1) Dipankar Saha (37) S/O Santosh Saha of Niranjnagar PO Ghogomali PS Bhaktinager dist. Jalpaiguri and (2) Ajay Sarkar (31) S/O Sunil Sarkar of Badurbagan PS Bhaktinager Dist. Jalpaiguri and to whom we disclosed our motto and identity and asked them to accompany us if any search and seizure is necessary for the purpose and they agreed. We reached at the Fakdaibari Necha busy ground Near Dabgram-II Beat office at about 00.55 hrs and found a group of 14-15 persons sitting at the Fakdaibari Necha busy ground Near Dabgram-II Beat office. We started approaching towards them slowly ambushing ourselves in the darkness. But unfortunately one of the people among the gang saw us and shouted "Police" at the top of his voice. Thereafter all of them started fleeing away. Anyhow, after a hot chase we could able to apprehend the 04 above referred accused persons. After apprehension the 04 persons disclosed their identity as noted above and also stated that there were 10/11 other persons with them and they were planning

to commit a dacoity on the house of a businessman at Kankata More area. Thereafter all the apprehended persons were searched in presence of the witnesses and the following articles were seized as follows:-

- i. One Khukri measuring about 11 inches in length made of iron including its wooden butt was recovered from the possession of accused Himu Jha (24) S/O Monoj Jha Of Sastri Nagar W/No 41, PS Bhaktinagar, Dist Jalpaiguri
- ii. One (1) Knife measuring about 11 inches in length made of iron including its wooden butt was recovered from the possession of accused Bijoy Patwari (27) S/O Adhir Patwari Of Bottle Company, Amtala, PS Bhaktinagar, Dist Jalpaiguri.
- iii. One (1) house breaking implement made of iron with pointed end measuring about 21" in length was recovered from the possession of accused Bicky Roy (20) S/O Kailash Roy Of Ektiasal, Near Hari Mandir, PS Bhaktinagar Dist Jalpaiguri.
- iv. One(1) iron rod measuring about 3 feet in length was recovered from the possession of accused Bhubesh Shil (22) S/O Sushil Shil Of Bottel Company, Near Banshjar, PS Bhaktinagar Dist Jalpaiguri.

Thereafter all the articles were seized in-between 01.15 hrs to 01.45 hrs. Issuing a proper seizure list duly signed by the witnesses and the accused persons. Thereafter all the persons were arrested after observing all formalities of arrest as they are assembled for committing heinous crime.

On the above circumstances, I pray before you that a specific case may kindly be started against the 04 arrested accused persons namely (1) Himu Jha (24) S/O Monoj Jha Of Sastri Nagar W/No 41, PS Bhaktinagar, Dist Jalpaiguri (2) Bijoy Patwari (27) S/O Adhir Patwari Of Bottle Company, Amtala, PS Bhaktinagar, Dist Jalpaiguri (3) Bicky Roy (20) S/O Kailash Roy Of Ektiasal, Near Hari Mandir, PS Bhaktinagar Dist Jalpaiguri (4) Bhubesh Shil (22) S/O Sushil Shil Of Bottel Company, Near Banshjar, PS Bhaktinagar Dist Jalpaiguri and 10/11 others unidentified persons for such assemble with deadly weapons and arrange for its investigation.
