Dear Sir,

With due respect I the undersigned would like to inform you that I am the legally married wife of Sri Uttam Paul and our marriage was solemnized on 09.12.2009 and after the said marriage I along with my husband started to live together as husband and wife and out of the said wedlock I gave birth of a female child on 07.06.2013.

I would like to further inform you that my husband tortured upon me both mentally and physically and for that I was compelled to lodge a written complaint to you on 13.07.2021 and on the basis of the said complaint one case has been registered being Bhaktinagar P.S. Case No. 869/2021 U/S - 498A of IPC.

I would like to further inform you that I have also filed a case under the provision of protection of women from Domestic Violence Act, 2005 before the Ld. CJM Jalpaiguri being Misc. Case No. 152/2022 and in the said case Ld. J.M. 2<sup>nd</sup> Court, Jalpaiguri was pleased to pass an order on 17.11.2022 directed my husband to pay a sum of Rs. 7,000/- for my maintenance and my minor daughter and also my husband is directed to provide a suitable accommodation to me and my husband has also restrained from committing any domestic violence and / or causing any violence to me and he is further restrained from alienating and / or disposing the share household property and / or encumbering the same until further order.

I would like to further inform you that inspite of the said order my husband sold and transferred the share household property the land measuring about 3 Kathas recorded in Khatian No. 831/1, 831/3, Plot No. 376/724, Mouza Dabgram, ward no. 39 of S.M.C. situated at Paulpara, P.S. Bhaktinagar, Dist. Jalpaiguri to one Smt. Mamata Karmakar, W/o. Sri Arun Karmakar against the valuable consideration and now my husband and said Mamata Karmakar and her husband along with their associates are trying to evict me forcibly from my matrimonial house illegally and violating the order of the Ld. Court and they are threatening me that if I will not vacate my matrimonial house, they will not hesitate to kill me and my minor daughter and nobody can trace out our dead body. I got an information from my reliable source that said purchaser Smt.

Shyamali Saha Paul

Mamata Karmakar and her husband came from Bangladesh and they procured the identity card by managing the local political influential persons for purchasing the said property.

Under the above circumstances I would like to request you to investigate the matter and give the protection as I could reside in my matrimonial house with my minor daughter freely and further requesting you to take the necessary action against my husband and said purchaser and her associates for violating the order of the Ld. Court for the ends of justice.
