I Sri Naiman Oraon S/o. Sri Baula Oraon, Vill: Rangamali, SF line, PO & PS : Mal, Pin: 735221 Dist : Jalpaiguri , I would like to inform you that :-

1. On 09.12.2022, Friday at about 12.50 pm coming from Gandar More to Fulbari by a bike. There was a car vide no. WB73G-3952 (White Coloured Maruty S Tour) Parked beside the left side of the road on the other side two men were urinating.
2. At the time of crossing a cow suddenly came in front of my bike. The said two men also tried to cross the road towards their car (WB73G-3592). The actual place of occurrence is in front of Khokan Motors, Mahendra workshop before Jatiakali.
3. A mild clash happened with my bike but no injury and damage done. In spite of all I appoliged with folded hand.
4. One of them (after words known by Mudit Bajoria) shouted and abused me with some slung words which were not fit for print out.
5. And another person (after words known by Anil Jain) grab my collar and asked my name. As soon as I told "Naiman Oraon", he said, "Saale Tu Adibashi Log, Kaise Bike Chalate Ho ? Nokor Admi Ko Bike Kon Diya".
6. Mr. Modit Bajoria also added "Tu Jaisa Chota Jaat Ko Bike Chalana Nahi Chahiye".
7. I protest vigorously and with my shouting some people, passing by interfere and make protest.
8. By the abrupt incident they were frightened and making way for escape from the spot. They alibied that they have to got flight for Kolkata from Bagdogra Airport. They hardly get it if they leave right now.
9. By the insist of people of Tangle they put one contact no. (98310-04822) and said their name which were mentioned above. (i) Mudit Bajoria (ii) Anil Jain. They also said, they have office at MacLeod House, Kolkata.

Somehow they could managed their way from the place of occurrence.

Now my humble submission is to you, after 75 years of Independence, being a Bhumi Putra of this country why should I neglected and abused for my caste and complexion!

My prayer to your good soul to take legal action against these brutal people and give them a good lesson.
