In producing herewith following articles under proper seizure list-

1] 10 (Ten) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml)

2] 06 (Six) bottles of G.E OYE 70up Country Spirit (each bottle containing 300 ml)

I, SI Rantu Haldar of Bhaktinagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one namely 1.Harish Ch. Roy S/O- Lt Dhiren Ch. Roy of New PrakashNagar, near Mahananda Bridge, W.No-43, P.S- Bhaktinagar, Dist- Jalpaiguri to the effect that today on 17/12/2022 at 22.10 hrs while performing evening patrolling duty, received a source information that one person namely Harish Ch. Roy is selling liquor in his hotel at Sevoke road near Suchitra Hotel under Bhaktinagar PS, without any valid license since last 04 (four) months. Accordingly I informed the matter to the I/C PS and as per his kind direction myself along with force- CVF/614 Sumit Kr Roy, CVF/619 Dharmendra Roy had been to Sevoke road near Suchitra Hotel under Bhaktinagar PS to verify the veracity of the information. On reaching there and as identified by the source I along with my force cordoned the area. But seeing us the above noted accused person could manage to flee away from the spot. I held raid thorough search in that hotel in course of which I recovered the above noted bottles of liquors inside of his hotel. I also examined several local people from whom identity of the owner of the said shop ascertained as mentioned above and also learnt that the above noted bottles of liquors were procured and stored by the above noted accused person illegally. And used to sell it to the local youths for his illegal gain. Accordingly, I seized the above noted bottles of liquors under proper seizure list .The search and seizure was made in between 22.55 hrs. to 23.25hrs.

I, therefore pray before your good self that a specific case may kindly be initiated against 1.Harish Ch. Roy S/O- Lt Dhiren Ch. Roy of New PrakashNagar, near Mahananda Bridge, W.No- 43, P.S- Bhaktinagar, Dist- Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
