
Subject:- Regarding Theft in the house.

On 15th December we returned back from Bangalore and found out that there has been theft in our house. The thieves have broken the door locks and entered the house. I am still figuring out all the loss items, but below are the major items which are missing Samsung 32 inch TV, Dell Laptop, Gas Cylinder - 2 number, Bran Kitchen Utensils. We are also not able to find death Certificate of Late M. C. Das (my husband) after this theft.
