I Pratika Subba, wife of Pranit Chhetri, permanent resident of ~~Wali~~ Darjeeling and currently residing at SBM Freshia 2 Apartment, Suidanga Siliguri, would humbly like to inform you that yesterday i.e 17th Dec 2022 at around 11:30 pm to 12 pm, me and my husband, who was driving the car had gone to drop his friends (Swal Yadav and Ravi Jha). But on the way, near Market Medical Shop anchal Champasani, a group of boys (around 5) who were in black colour sedan stopped the car and physically started assaulting me, my husband and his friends and also snatched his car keys and took away his phone (Iphone 13, white colour). Later when he tried to defend ourselves they called more boys who came in Scooty and bikes and immediately started throwing stones at us as well as our car. As a result of this action our car has been severely damaged and my husband and his friends are injured. Later when the police arrived at the site, they all fled away from the spot leaving us along with damaged car. The details of my car is white colour Kia Sonet bearing no. (WB 74 BE 3400). My husband works in UCB Bank as senior manager, hence his phone has all vital documents related to bank. So kindly request you to track and retrieve his phone at the earliest.
