Respected Sir,

I, Chandni Chakrabarti, w/o Joy Prakash Chakrabarti, P/O Naya Barty, W.No 46, Charpasari, P.S Pradhan Nagar, would like to bring to your kind notice that my son, Bijay Chakrabarti aged about 31 yrs was returning from a cultural program from Dakshin Palash as stated by him at about 11:30 pm approx today 17/12/22.

That, when he reached near Allahabad Bank of Charpasari, the above mentioned vehicle suddenly stopped my son's car from opposite side and while protesting for the same, 2-3 people came out from the vehicle No. WB74BE-3400 and started beating and assaulting my son without any provocation due to which my son has sustained grievous injuries on his chest, face and head.

After this, public gathered and released my son and sent him to the nearest North Bengal Medical Hospital Emergency Dept. and treated him vide Memo No. 670 of their Emergency Case Sheet and has admitted him after various investigations for further better treatment, and he is under their medical supervision.
