Thereafter ~~our~~ my name and my five brothers name and my mother's name have recorded in respect of the said 10 Kathas of land and seven new R.O.R have been open in our name being khatians no- 6437, 6439, 6440, 6441, 6442, 6438 and 6443

That today at about 10-30 A.M when I along with my brothers were working on the above said land for repairing, suddenly (i) Chhotu Yadav, s/o-Lt. Ram and Yadav, (ii) Sushila Devi Yadav, w/o-Lt. Ram and Yadav, (iii) Menni Devi Yadav, w/o- Amarjit Yadav (iv) Arati Yadav, o/w- Maheswar Yadav all are resident of Tumbajote, PO+PS - Matigata, Dist - Darjeeling came to my above mentioned land with some unknown anti social persons. They started to beat me and my brothers with birst and blow and they also threatened me and my brothers with dire consequences. They also threatened that I along with my brothers will be murdered if we try to work in ^{my} land. They pelted stones to us, Chhotu Yadav also kicked on my waist and I fell down and then Chhotu Yadav and his associates have snatched one Golden chain from my neck measuring about 11 grams and they left the place after gathering people of the same locality.

Therefore, I request you to look into the matter and request you to ~~check~~ investigate the matter and do the needful by putting the culprits behind the bar.

And for this act of kindness, I shall be grateful to you and shall ever pray.
