meet my brother near Adarsh Mahavidyalay, Ward No. 42  
and as it was night time my brother Manish  
Gupta (since deceased) accompanying me and went  
near Adarsh Mahavidyalay and after reaching there  
we found that Ankit Sharma was present there  
along with his brothers above mentioned.

and the accused persons were continuously threatening us as they will kill us and suddenly Ankit and his brothers started to assault my brother and me with wooden clubs and rods and hearing our hue and cry some of the local passer by came to rescue us and at the same time above Ankit Sharma stabbed my brother (since deceased) with knife and inflicted multiple severe injuries on my brother's bodily parts and due to such assault my brother sustained severe injuries and due to huge amount of bleeding, I along with my neighbors and persons who were present during the occurrence took my brother to Lifeline Hospital and the above mentioned accused persons fled away and after reaching to hospital my brother died due to severe injuries.

It is to be mentioned here that the above mentioned persons regularly deals in illegal drugs & Narcotic products and there are several cases against them which are pending before the court of law.

Therefore, I request you to kindly lodge a F.I.R against the above-named accused persons and punish as per law.
