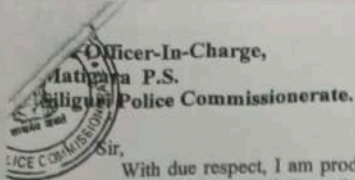

Sir,

With due respect, I am producing herewith 04 (four) arrested accused persons namely (i) Suman Sha (19 yrs) S/O Suresh Sha of Matigara Rail Gate, Biswas Colony, PS- Matigara, Dist.- Darjeeling (ii) Md Afjal (20 yrs) S/O Md Alam of Matigara Rail Gate, Biswas Colony, PS- Matigara, Dist.- Darjeeling (iii) Babu Sarkar @ Kalababu (51 yrs) S/O Late Manmahan Sarkar of Kuria Patty, Biswas Colony, PS- Matigara, Dist.- Darjeeling (iv) Abhishek Roy (19 yrs) S/O Dahari Roy of Pelku Jote, Ranidanga, PS- Matigara, Dist.- Darjeeling the following articles under seizure :-

1. One iron made sharp cutting weapons called as Bhojali recovered from the possession of accused Suman Sha S/O Suresh Sha of Matigara Rail Gate, Biswas Colony, PS- Matigara, Dist.- Darjeeling.
2. One steel made sharp cutting knife & one touch light recovered from the possession of accused Md Afjal S/O Md Alam of Matigara Rail Gate, Biswas Colony, PS- Matigara, Dist.- Darjeeling.
3. One iron made sharp cutting knife and one iron rod recovered from the possession of accused Babu Sarkar @ Kalababu S/O Late Manmahan Sarkar of Kuria Patty, Biswas Colony, PS- Matigara, Dist.- Darjeeling.
4. One iron made sharp cutting weapon called as Vojali and one iron rod recovered from the possession of accd Abhishek Roy S/O Dahari Roy of Pelku Jote, Ranidanga, PS- Matigara, Dist.- Darjeeling.

I, SI Goutam Mallik of Matigara PS, Siliguri Police Commissionerate beg to state that on 20.12.22 at 01.15 hrs received a reliable secret source information that that a gang of miscreants come at foot ball ground near Barsana Hotel under PS- Matigara, Dist.- Darjeeling with deadly weapons and assembled there and making preparation for committing dacoity at Mota Jote area under Matigara PS. Accordingly, I diarized the fact in General Diary vide Matigara PS GDE No 1029 dated 20.12.22 and informed the fact the Officer-In-Charge, Matigara PS, SPC. As per his kind order and direction myself along with C/ 974 Mintu Sen, C/1053 Paresh Rava, C/219 Sanatan Chitrakar, C/374 Debraj Biswas, CV-155 Sukumar Das and CV-387 Sukumar Barman all of Matigara PS, SPC left for near Barsana Hotel under PS- Matigara, Dist.- Darjeeling to verify the veracity of said source input vide Matigara PS GDE No 1029 dated 20.12.22. I also informed the fact to Night RT Van officer Md Sanaulla and ASI Prabir Roy both of Matigara PS and directed them come to near Barsana Hotel to accompany with us. At 01.35 hrs we arrived at beside the football ground near Barsana Hotel under PS- Matigara, Dist.- Darjeeling. After a few time RT Van Officer Md Sanaulla and ASI Prabir Roy along with force came to there and accompany with us. At about 01.45 hrs as indicated by the source we noticed that 12/14 persons assembled in a dark place right side of the foot ball ground near Barsana Hotel and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started to flee away from the spot but we the police party after a hot chase managed to apprehended 04 (four) of them with deadly weapons in their possession but 08/09 persons managed to fled away from the spot taking the advantage of darkness and open place. On interrogation the apprehended accused persons disclosed their name and identity as noted above. During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night. Finally, they disclosed that they were assembled there for committing dacoity in a house at Mota Jote area. On search the above noted weapon of offence recovered from their possession.

Accordingly, I seized the above noted weapon of offence from their possession under proper seizure list and arrested them under proper memo of arrest and observing all the formalities of arrest and brought them to Matigara PS. The search seizure and arrest made on 20.12.22 in between 02.35 hrs and 03.45 hrs.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the above noted 04 (four) arrested accused persons namely (i) Suman Sha (19 yrs) S/O Suresh Sha of Matigara Rail Gate, Biswas Colony, PS- Matigara, Dist.- Darjeeling (ii) Md Afjal (20 yrs) S/O Md Alam of Matigara Rail Gate, Biswas Colony, PS- Matigara, Dist.- Darjeeling (iii) Babu Sarkar @ Kalababu (51 yrs) S/O Late Manmahan Sarkar of Kuria Patty, Biswas Colony, PS- Matigara, Dist.- Darjeeling (iv) Abhishek Roy (19 yrs) S/O Dahari Roy of Pelku Jote, Ranidanga, PS- Matigara, Dist.- Darjeeling and others 08/09 unknown persons and arrange for its investigation.
