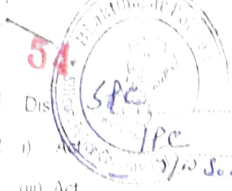

Reference: Violation of West Bengal Clinical Establishment Act by above mention group of people.

We wants to lodge an FIR that yesterday on 18<sup>th</sup> December'22 around midnight a group of people came to our Emergency unit with a Patient named Mr.Manish Gupta,M/28yrs. The patient came with Stab injury and immediately attended by our two senior Registered Medical officers and started treatment as per the protocol following emergency treatment and explain the critical condition of patient to the relative.

The patient expired in next 20 minutes. Suddenly the patient's associate became unruly and they even chased our Night duty executive Mr.Sarajenu De Sarkar who went to the PS to submit the MLC form. There one Mr.Manu Gupta who happens to be the brother of Deceased patient Mr.Manish hit him from the back and manhandled. Seeing this from the PS few police personnel rushed and rescued our person also helped him to leave the place in an Ambulance. *In the mean time sum of them try to restrain police personnel & pushed them then also kicked on the police van & try to Damaged the police van.*  
The patient's associates left our hospital premises that night by saying they will take the body on next day.

*19.12.22*

Today around 10.30 am a group of 20-30 people came to our hospital and without any provocation they started using filthy languages to our staffs including lady staffs and manhandled namely Surender Sharma , Ranjit Singh( Maa Durga Hotel), Bullet Singh among the others. Within no time the mob became unruly and started ransacking our hospital properties which leads huge loss for us and also many materials are missing. These accounts around rupees 5 lacs.

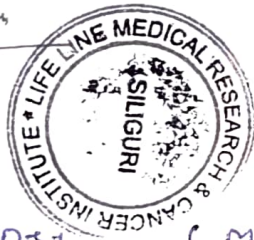
