Subject: Written Complaint

Respected Sir,

Most humbly I, RAJU DAS, S/o Ram Balak Das, r/o Champasari, Debidanga, Siliguri, Dist.-Darjeeling do hereby make this written complaint before you stating as follows :

1. That I am a businessman by profession and have been working as a contractor since long in and around Siliguri and looking to expand my business area.
2. That in the year 2021 during the course of my business I came to know one person namely SRI RAJ PANDEY, s/o not known, r/o Kharmanchowk, Uma Charan Bose Lane, P.O.-Bhagalpur, P.S.-Joxar, Adampur, PIN-812001, Bihar who introduced himself as Deputy Collector presently posted in Bihar Secretariat, Patna. It is pertinent to mention that the said SRI RAJ PANDEY used to travel in a red light vehicle along with arms and ammunitions which he claimed that it was for his security issued by the Bihar Secretariat, Patna
3. That it is pertinent to mention herein while we were introduced to each other the said SRI RAJ PANDEY informed me that he regularly visits Siliguri for his official works and used to stay for a month at a Hotel namely 'Four Fox Hotel' situated at Champasari, Pokaijote Road, Siliguri, Dist.-Darjeeling.
4. That in the month of September, 2021 SRI RAJ PANDEY told me that he has connections with the high-ranked officers of the Govt. Of West Bengal and if I pay him a sum of Rs.50,000/- he will help me in developing my construction business in a more proper manner.
5. That thereafter I somehow manage to gather the sum of Rs.10,000/- (Rupees Ten Thousand) only out of Rs. 50,000/-(Rupees Fifty

Thousand) in cash and handed over the same to SRI RAJ PANDEY but as time passed on I did not received a single help from his side.

6. That since the month of September, 2021 repeatedly I asked RAJ PANDEY as to how he is going to help me with my business and also enquired about the amount of money which I paid to him in good faith but each and every time he avoided me on several pretext and since September, 2022 he started to threaten me with dire consequences if I again ask for money. It is worthy here to mention that said RAJ PANDEY told me that he has connections with the top level police officers of Siliguri Police Commissionerate and if I insisted for payment of the said sum of Rs.50,000/- (Rupees Fifty Thousand) only from him then he will implicate me with false criminal prosecution even I may be implicated with commercial quantity of N.D.P.S Case.
7. That it is also pertinent to mention herein that the said RAJ PANDEY has been continuously threatening me and pressurizing me for more money over phone from his mobile number being 79911-26055.
8. That due to such mental torture by said RAJ PANDEY I along with my family including my wife, my children are living in great anxiety, mental trauma, shock and psychological sufferings which disturbed/destroyed my family life.
9. That I borrowed the money amounting to Rs.50,000/- (Rupees Fifty Thousand) only from different persons on high interest basis and I am paying regular interest to the borrowers because of such unethical conduct of said RAJ PANDEY.
10. That it is also very important to mention here that whenever I met with said RAJ PANDEY he always carries firearm which he showed me on regular basis to put me in fear of bodily injury or death.
11. That from the acts and conducts it became crystal clear to me that SRI RAJ PANDEY by taking the undue advantage of his position as the Deputy Collector presently posted in Bihar Secretariat, Patna with an intention to grab money for his own benefits induced me to pay an
