I **MONIKA LAKHOTIA**, Wife of Manish Lakhota, Daughter of Sri B.L Karnani, Hindu by faith, Presently residing at Ashtha Apartment, Champasari, Opposite Aman Medical, Naya Basti, Siliguri P.O. & P.S. Pradhan Nagar, District - Darjeeling - 734003 would like to draw your kind attention in the matter as follows :-

1. That I am married to Manish Lakhota S/o Sri Raj Kumar Lakhota. Our marriage was solemnized on 19th January, 2004 at Maheshwari Bhawan, Agresen Road, Siliguri and we have two daughters from the said marriage namely Yashvi Lakhota and Urvi Lakhota.
2. That since few months my in-laws and husband has been continuously torturing and threatening me to leave my matrimonial house or else I will face dire consequences compelling of which I was forced to lodge a written complaint to the Pradhannagar Police Station on 22.09.2022 in respect of which a specific case vide Pradhannagar P.S. case No. 1369/2022 has been initiated under Section 498 A of Indian Penal Code at Siliguri.
3. That I have also filed an application under section 12 of The Protection Of Women From The Domestic Violence Act, 2005 and the same is registered as Misc. Case No. 192/2022 pending before the J.M. 1st Court at Siliguri.
4. That today morning, when I left my home to go out for some work after sending my children to school, I got a information from my neighbor that my in-laws have called a pick-up van and are loading all things including my clothes and other belongings of my children and mine .

5. That I immediately rushed to my matrimonial home at Astha Apartment, Champasari, Opposite Aman Medical, Naya Basti, Siliguri, P.O. & P.S. Pradhan Nagar, Dist: Darjeeling – 734003, but my in-laws had locked the main gate and denied to allow me to enter the house. They started hurling abuses at me and called my children unwanted and asked me to immediately leave Siliguri else they would not let me live peacefully.

It is pertinent to mention here that since few days my in-laws were threatening that they would oust me and my children from my matrimonial home by any means.

6. That now my daughters have returned from school without any knowledge of the incident and they are standing outside out house in a state of utmost shock and famished.
7. That now I and my children are left homeless and I am in a state of true perfidy. I am in the state of helplessness and all my endurance have failed.

Therefore you are humbly requested to look after the matter and take strict action against the aforesaid culprits and help me enter my home as soon as possible .
