Sir,

With due respect, I am producing herewith one arrested accused person namely Sanjit Sarkar (45) s/o Lt. Sunil Sarkar of South Colony, near Gandhi More, PS-New Jalpaiguri, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

- 1. 13 (Thirteen) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml),
- 2. 05 (Five) bottles of Haywards 5000 Super strong beer containing 650 ml. in each bottle.

I, SI-Pradeep Diyali presently attached with NJP PS under your kind control beg to state that today i.e. on 20.12.2022 at 1815 hrs I received a secret source information that one person namely Sanjit Sarkar (45) s/o Lt. Sunil Sarkar of South Colony, near Gandhi More, PS-New Jalpaiguri, Dist.- Jalpaiguri is selling ID liquor illegally at his shop at South Colony at his resident, PS- NJP, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No.922 dated 20.12.2022 and informed the fact to you. As per your kind direction and instruction myself along with VP/08 Iaxman Roy, VP/13 Jamirul Islam, CV/306 Biswajit Roy, CV/824 Niru Kumar Yadasv all of NJP PS, SPC left for South Colony, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 1835 hrs we arrived at South Colony, near Gandhi More, under New Jalpaiguri PS, Dist.- Jalpaiguri, and being identified by the source I held raid at the resident of the said accused and managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his house since long for his illegal gain. On search the above noted I/D liquor recovered from his shop. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 1905 hrs to 1935 hrs

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Sanjit Sarkar (45) s/o Lt. Sunil Sarkar of South Colony, near Gandhi More, PS-New Jalpaiguri, Dist.- Jalpaiguri and arrange for its Investigation.
