With due respect, I am producing herewith Eight (08) arrested accused persons namely (i) Girish Roy (62) s/o Lt. I, ASI Sajal Das presently attached with NJP PS under your kind control beg to state that today i.e. on 20.12.2022 at 2105 hrs I received a secret source information that some persons of South Colony resident area playing Glambing at abandoned quarter. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No.929 dated 20.12.2022 and informed the fact to you. As per your kind direction and instruction, myself along with VP/08 Laxman Roy, VP/13 Jamirul Islam, CV/306 Biswajit Roy, CV/824 Niru Kumar Yadav all of NJP PS, SPC left for South Colony, PS- NJP, Dist- Jalpaiguri to work out the information in hand. In the mean time, I informed the fact to RT Van Officer namely ASI Dhurba Kumar Mishra of New Jalpaiguri PS, Siliguri Police Commissionerate. At about 2135 hrs we arrived at South Colony, near Gandhi More, under New Jalpaiguri PS, Dist- Jalpaiguri, and cordoned the area with the assistant of RT Van Officer and Force and being identified by the source I held raid at the at abandoned quarter place at South Colony, near Gandhi More, PS- New Jalpaiguri, Dist- Jalpaiguri and successfully apprehended 08 (Eight) persons playing Glambing. On being asked they disclosed their name and address as noted above. On further interrogation they were playing glambing since very long for their wrongfull gain and Wrongful loss. Accordingly on being search I, recovered one bundle of Red and white color playing Card and Rupees 1930/- [One Thousand Nine Hundred Thirty Rupees] from their possession. Accordingly, I seized all the recovered article after preparing proper seizure list and arrested all the accused persons after issuing proper memo of arrest. The whole processes of search and seizure was made in between 2155 hrs to 2235 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely (i) Girish Roy (62) s/o Lt.
