

Sub – Request for Lodging a F.I.R against Mr. Premdhan Sarkar and Mrs. Rekha Sarkar


Sir/Madam

My medical treatment is still going on. Now, it's become very difficult for me to reside here. Me and my family are mentally tortured by their threaten.
