I, Bapi Chowdhury, S/O P.N. Chowdhury, the Secretary of Siliguri, Mallaguri Wholesale Fish Merchant Welfare Association, Vide Registration No. 81345, situated at Regulated Market (Fish Complex), Mallaguri, P.O & P.S. Pradhan Nagar, Dist- Darjeeling, do hereby want to inform you as follows :-

1. That our Registered Office is situated in above mention address.
2. That i) **GANESH SINGH**, S/O Late Girwal Singh, Resident of Gurung Busty, Pradhan Nagar; Dist. Darjeeling, Ph No. 9563385027 ii) **PRADEEP GUPTA**, Son of Rabindra Prasad Gupta, Resident of Near Champasari More, SBI, Bank, P.S. Pradhan Nagar, Dist. Darjeeling; Ph No. 6290931901 was running a shop room at Regulated Market (Fish Complex), Mallaguri without any authority and permission, illegally running illegal business into the said shop room and was also selling a illegal articles into his said shop room upon his muscle power.
3. That the above named accused persons are very desperate in nature and they used to extort money from the other stall owners and if any stall owners refused to give money then the above named accused person used to treat them for their lives.

That subsequently the said above named persons have also started to place their illegal goods in front of their shop whereas as per our market association rules there is specified and specific place for keeping the store articles, but the above named accused persons using their muscle power started to keep their illegal goods vehicle on the walking passages forcefully and intentionally only to create disturbance for the other members and to create a havoc.

That subsequently today on 21.12.2022 at around 6:45 am in this regard when I along with my other members protested against these kind of activities then the i) **GANESH SINGH**, S/O Late Girwal Singh, Resident of Gurung Busty, Pradhan Nagar; Dist. Darjeeling, Ph No. 9563385027 ii) **PRADEEP GUPTA**, Son of Rabindra Prasad Gupta, Resident of Near Champasari More, SBI, Bank, P.S. Pradhan Nagar, Dist. Darjeeling; Ph No. 6290931901 started to bit me, pushed me towards the floor, snatched Rs. 10,000/- (Rupees Ten Thousand) only forcefully from me and started to threatened me to kill me and my other members and also threat us that they will implicate us in false cases.
7. That during the time of attack the above named accused persons intentionally ransacked our office and forcefully looted away various documents from our office with an intention to destroy the whole association for that we cannot run our office smoothly.

Therefore, in the light of the above facts and circumstances it is prayed to you that you may take necessary action for restraining the above named accused person from their illegal acts and conducts and may protect life of our members as well as the property of our association, so that our association can perform its duty smoothly.
