and Other unknown miscreants.

Sir,

In producing here with one arrested accused person namely Guddu Kumar (30 yrs) S/O Shambu Giri of Ward No. 6, PO Siswa, Banjaria, East Champaran, Bihar (Present Address: GS Dutta Road, Pipe Line, Bharat Nagar, Siliguri (M.Crop), Dist. Darjeeling) along with Memo of arrest, seizure list and seized articles as per seizure list enclosed. I, do hereby, lodge this written complaint to the effect

1. THAT, on 20.12.2022 I, Inspector Biswasroy Sarkar of STF, WB, HQ at Siliguri received information through my credible source that one Guddu Kumar of GS Dutta Road, Pipe Line, Bharat Nagar, Siliguri (M.Crop), Dist. Darjeeling was in touch with PIO (Pakistani Intelligence Operative) and was supplying classified information and documents which might compromise with the National security and sovereignty of our nation in lieu of money. It was also learnt that his movements were seen at and around vital defence (Army and Air Force) and other vital Govt. installations at Sukuna, Darjeeling and Indian Air Force Base at Bagdogra, Siliguri and New Jalpaiguri.

2. THAT, the source information was diarized vide STF WB, HQ at Siliguri, GDE 225 Dated 19.12.2022 and superiors had duly been apprised about that information. I was directed by the Superiors, STF, WB to conduct a secret enquiry over the information in hand as noted above.

3. THAT, the local secret enquiry revealed that the said Guddu Kumar S/O Shambu Giri worked as a Mathematics

the security, sovereignty and integrity of the State and India. He had admitted that all the communications were made illegally with the foreign agents.

9. THAT, it was found that, he was involved with some offences punishable under law of land therefore on 21.12.22 at 07.05 hrs, I detained the said Guddu Kumar and seized all relevant documents, mobile phone and scooter.

After examination of the said person as noted above, it is crystal clear that the subject was used as an illegal instrument by providing secret information, photos which can be compromising and threatening the national security of India which could be advantage to the hostile neighboring countries. As a prima facie implication of Guddu Kumar with many offences under Official Secrets Act, 1923 and IPC have been revealed therefore, on the basis of prima facie evidence and his statement, he has been arrested after observing due legal formalities and he would be produced before the Ld. Court, Jalpaiguri within stipulated time.

Under circumstance as stated above, I request your good self to start a specific case against Guddu Kumar (30 yrs) S/O Shambu Giri of Ward No. 6, PO Siswa, Banjaria, East Champaran, Bihar (Present Address: GS Dutta Road, Pipe Line, Bharat Nagar, Siliguri (M.Crop), Dist. Darjeeling) and Others unknown u/s 120B IPC read with Sec. 3/4/5/10 of Official Secrecy Act on this complaint along with the seizure list enclosed.
