Dear Sir,

I, SRI AVIJEET SANYAL, Son of Debasis Sanyal, Resident of Raikatpara, P.S. Kotwali, District Jalpaiguri and a student of Department of Anthropology, University of North Bengal, would like to bring to your kind notice and state as follows:

- That I, along with numerous students, teachers, non-teaching Staff, ex-students have been involved in a
  movement against the transfer of University property to private entity and in the course of such democratic
  movement a meeting was scheduled to be held today, i.e. 21.12.2022, at about 11 A.M. in front of
  Administrative Block, NBU Campus.
- 2. That today, at about 10:45 am, while I reached near the Administrative Block, NBU, few persons namely (1) Sri Sudash Lama, Son of Maila Lama of Qtr. No. E/27, NBU Campus, P.S. Matigara, District Darjeeling, (2) Sri Mithun Baisya, Father's name not nown, Resident of Purba Saradapally, Kadamtala, P.S. Matigara, District Darjeeling along with few other anti-social elements suddenly attacked and assaulted me vigorously. The said Sudash Lama provoked and instigated this situation. The said Mithun Baisya jumped upon me by grabbing my throat and punched me one after another. His intention was clear to bring severe assault on myself and as a result I sustained severe injuries in my throat and chest. However, in the mean time few other students came to my rescue and I could somehow save my life, although I sustained severe injuries in my throat in the turmoil and thereafter my friends took me for treatment in the health centre of North Bengal University.
- That the incident took place in broad day light in presence of many students, teachers, non teaching staff and
  others who had gathered in front of the Administrative Block to attend the meeting scheduled and participate
  in the Democratic movement against the land transfer.
- That I could, some how survive due to the intervention of the students and others, who came to my rescue
  and due to the presence of the persons rescuing me the said Mithun Baisya and others fled the spot.

I therefore kindly pray before your goodself to do the needful in this regard and take appropriate legal action against the accused persons for the ends of justice and consider my prayer as FIR.
