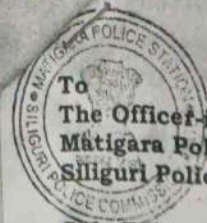

Sir,

In producing herewith 02 (two) arrested accused persons namely (i) Nagendar Singh (49 yrs) S/O Ranjeet Singh of Vill+PO- Jomui, PS- Sikendarpur, Dist.- Balia, Uttar Pradesh and (ii) Subhankar Sarkar (50 yrs) S/O Late Manindar Sarkar of Vill+PO+PS- Talebpur, Dist.- Murshidabad under arrest and following articles under seizure :-

1. One ten wheeler truck displaying number plate WB/57/A/4716 loaded with following articles :-

(a) 10 (ten) numbers of brown colour paper made big cartoon wrapped with brown colour nylon polythine, each cartoon containing 600 (six hundred) packets of "SPIDERMAN SOUND CRACKERS" i.e. total $(600 \times 10) = 6000$ (six thousand) packets of "SPIDERMAN SOUND CRACKERS" and each packet containing 10 pcs of "SPIDERMAN SOUND CRACKERS" i.e. total $(6000 \times 10) = 60,000$ (sixty thousand) pcs of sound crackers value of Rs 380/- (three hundred eighty only) each packet, Total value $(6000 \times Rs 380/-) = 2,280,000/-$ (Twenty two Laks eighty thousand only) and total weight 65 kgs of each cartoon i.e. total weight $(65 \text{ Kgs} \times 10) = 650 \text{ Kg}$.

(b) 05 (five) numbers of brown colour paper made big cartoon wrapped with brown colour nylon polythine, each cartoon containing 840 (Eight hundred forty) packets of "FANCY BIG CHOCOLATE SOUND CRACKERS" i.e. total $(840 \times 05) = 4200$ (four thousand two hundred) packets of "FANCY BIG CHOCOLATE SOUND CRACKERS" and each packet containing 12 pcs of "FANCY BIG CHOCOLATE SOUND CRACKERS" i.e. total $(4200 \times 12) = 50,400$ (fifty thousand four hundred) pcs of sound crackers total weight 66 kgs of each cartoon i.e. total weight $(66 \text{ Kgs} \times 05) = 330 \text{ Kg}$.

I, SI Goutam Mallik of Matigara Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the above mentioned 02 (two) arrested accused persons namely (i) Nagendar Singh (49 yrs) S/O Ranjeet Singh of Vill+PO- Jomui, PS- Sikendarpur, Dist.- Balia, Uttar Pradesh and (ii) Subhankar Sarkar (50 yrs) S/O Late Manindar Sarkar of Vill+PO+PS- Talebpur, Dist.- Murshidabad to the effect that today on 24.12.2022 at 10.05 hrs received a reliable secret source information that one truck having registration number WB/57/A/4716 loaded with illegal fire crackers is standing at Paribahan Nagar under PS- Matigara, Dist. Darjeeling. Accordingly, I diarized the fact in General diary vide Matigara PS- GDE No 1256 dated 24.12.22 and informed the fact to the Officer-In-Charge, Matigara PS and as per his kind order and direction myself along with C/ 974 Mintu Sen, C/1053 Paresh Rava, C/219 Sanatan Chitrakar, C/374 Debraj Biswas, CV-155 Sukumar Das and CV- 387 Sukumar Barman all of Matigara PS left for Paribahan Nagar under PS- Matigara, Dist.- Darjeeling to work out the information in hand. At about 10.25 hrs we arrived at paribahan Nagar and as indicated by the source, I found one truck displaying number plate WB/57/A/4716 is standing at Paribahan Nagar and two pesons inside the said truck. On being asked one person disclosed his identity as Nagendar Singh (49 yrs) S/O Ranjeet Singh of Vill+PO- Jomui, PS- Sikendarpur, Dist.- Balia, Uttar Pradesh and also disclosed that he is the driver of the said vehicle and another person disclosed his identity as Subhankar Sarkar (50 yrs) S/O Late Manindar Sarkar of Vill+PO+PS- Talebpur, Dist.- Murshidabad and also disclosed that he is the Co-driver of the said vehicle. On interrogation initially they did not give any satisfactory reply regarding the goods loaded in their vehicle but finally they disclosed that there is total 15 (fifteen) cartoons of illegal fire crackers loaded in their vehicle. On search the vehicle, I found the above noted illegal fire crackers loaded in the vehicle. On demand they failed to produce any documents in respect of the said fire crackers loaded in the vehicle. There is a reason to believe that accused namely (i) Nagendar Singh (49 yrs) S/O Ranjeet Singh of Vill+PO- Jomui, PS- Sikendarpur, Dist.- Balia, Uttar Pradesh and (ii) Subhankar Sarkar (50 yrs) S/O Late Manindar Sarkar of Vill+PO+PS- Talebpur, Dist.- Murshidabad carrying the said illegal consignment of fire crackers in their vehicle for selling the same to their design customers for their wrongful gain, which are combustible in nature and endanger to human life and property violating Govt. Orders. Moreover, the above noted fire crackers were loaded in their vehicle without any precautionary and safety measures.

Accordingly, I seized the above noted vehicle loaded with above noted illegal fire crackers under proper seizure list duly signed by the witnesses and acknowledged by the accused persons namely i) Nagendar Singh (49 yrs) S/O Ranjeet Singh of Vill+PO- Jomui, PS- Sikendarpur, Dist.- Balia, Uttar Pradesh and (ii) Subhankar Sarkar (50 yrs) S/O Late Manindar Sarkar of Vill+PO+PS- Talebpur, Dist.- Murshidabad. The whole process of search seizure was made between 11.25 hrs to 14.45 hrs. Subsequently, I arrested the above noted accused person namely i) Nagendar Singh (49 yrs) S/O Ranjeet Singh of Vill+PO- Jomui, PS- Sikendarpur, Dist.- Balia, Uttar Pradesh and (ii) Subhankar Sarkar (50 yrs) S/O Late Manindar Sarkar of Vill-PO+PS- Talebpur, Dist.- Murshidabad observing all the formalities and informing the ground of their arrest.

Under the above fact and circumstance, I pray before you that a specific case may kindly be started against the accused persons namely i) Nagendar Singh (49 yrs) S/O Ranjeet Singh of Vill+PO- Jomui, PS- Sikendarpur, Dist.- Balia, Uttar Pradesh and (ii) Subhankar Sarkar (50 yrs) S/O Late Manindar Sarkar of Vill-PO+PS- Talebpur, Dist.- Murshidabad under proper section of law and arrange for its investigation.
