Upasana Apartment, Siliguri, W.B.734001

Sir

This is to inform you that I am residing at middle floor of my newly constructed house (G+2) at Zila Parisad Road, Opposite- Upasana Apartment, Siliguri, WB. I left my house under lock on 4th Dec at 9:30 hrs to Delhi & Chennai for Medical Treatment. I have returned to Siliguri on 15th December. No one was present in my house during whole day and night of 4th/5th Dec. It is suspected that some person/thief entered in my house from back door (perhaps which was not locked mistakenly) and searched/took keys of almirah which were kept in my room itself and took away my Jewellery costing about 8-9 lakhs. On 5th morning when my mother reached in my house to stay in my absence, I came to know that theft has occurred in my house on 4th/5th night as cash Rs. 7000/- which was kept by me on the table for payment of fee of home teacher of son/house maid etc was missing.

After returning back on 15th, I rechecked the missing items from my house and found that following items have been stolen by some thieves in the night of 04th/5th Dec.

- 1. Cash Amount Rs. 7000/-
- 2. Jewellery items costing about Rs 8-9 lakhs (As listed in Annexure-A)

As such my house is newly constructed and furniture work had been completed during last two months by Head Carpenter/Petty contractor Mr. Jitesh (M-9832872280, 8617572121) and his team. They have also done all doorlocks work in my house. In fact 2 days before my leaving, his two Mistry attended my Almirah etc in my room. I have strong doubt that these two Carpenter Mistry must have done above theft.

Though information of theft was given to me by my mother on 5th itself, FIR could not be filed earlier as because I was out of Siliguri at Delhi & Chennai for Medical Treatment purpose and after returning only I could see and confirmed personally the stolen jewellery items.

It is requested to kindly register my FIR against above theft occurred in my locked house on 4th/5th night and investigate the case so as my stolen jewellery is recover at the earliest.
