I Dhurba subba ,son of Deepak subba resident of sisabari, Champasari ,
P.S. Pradhan nagar, District Darjeeling, West Bengal, do here by beg to state you
as:-

1. That I am the caretaker of the land measuring 42 kathas at mouza Darigramer
chatt, JL.no 40, L.R Plot No.22 ,recorded in L.R Khatian 101,102,103,104,105,106
&107 by way of agreement with the original Khatian Owners.

That I have searched the said khatian through proper channel and
even by filing an R.T.I , which shows that the above mention khatian is proper
without any encumbrance ,both in terms of paper and position . The said land has
been under the possession of the above mentioned khatian owner for around
almost 12 years .

And that by the permission of the above mentioned khatian owner I was
constructing a boundary wall and demarcation over the said land by engaging
skilled mistry and labour

2. That around 4 month prior a person named **Deepak oraon** S\O Johan oraon
resident of mohurgaon Tea Estate ,P.S Pradhan nagar, Darjeeling, along with
some land mafias and antisocial elements came to the above mentioned plot and
destroyed my undergoing construction when asked for the reason he simply
asked for ransom and half of the land as well, when asked for the reason he
threatened me that if I don't comply with his demands he's going to hurt me in
coming future.

3. That after the above mentioned incident happened I filed an F.I.R and after that a thorough investigation was done by the Pradhan nagar police and after the investigation I was said that my documents are all ok and I don't need to fear anything and accordingly I restarted my construction.

That after I restarted my boundary construction the above mentioned Deepak oroan came again along with some land mafias and antisocial elements and threaten my mistry and labour and even took away my construction shuttering, I again lodged a complaint against him and I was assured that my land is legal and i may do whatever I desire to do with my land . After that given assurance I again started my construction process and on 20.12.22 The above mentioned Deepak oroan again came along with his goons and threaten me , my mistry and labours.

That the above mentioned **Deepak oraon** comes along carrying a document which does not have any record in the B.L.R.O office or any other concerned department .After some time it came to my knowledge that the above mentioned Deepak oraon and his associates named **Rajen kujur S/o Larangu kujur R/O Jadubhita ,Champasari ,Matigar,P.S Pradhan Nagar ,West bengal,** goes to every land owned by various people and shows all kind of forged documents which does not have any legal background , or record in any government offices that being whether BLRO ,SDLRO or any other concerned offices.

That this is not for the first time that they have targeted the land owned by me , even earlier Rajen kujur caused some chaos in my land situated in the same mouza/ area by showing all kind of documents ,at the time not knowing of his illegal habit i was forced to pay him the amount of ₹ 6,11,000/ which i paid him through cheque no .209052 & 209053,after paying the amount it came to my knowledge that the documents provided was him was forged and the person concerned in the said document was totally a different person bearing the photo and Identity card of some other individual.

That it has come to my knowledge that said Deepak oraon and Rajen kujur have extorted not only me but also various other people, at first they targeted my land later on they gathered all kind of baseless documents and then conspired to Harass me and extort money from me which i was forced to pay

As it has clearly come to your knowledge that this is not for the first time that the above mentioned Deepak oroan and Rajen kujur has threaten me causing obstruction on my plot and harassing me with all sorts of forged documents and conspired against me ,so in view of above I request you to kindly do the needful and take a strict action so that the said Deepak oraon ,Rajen kujur shall be put behind the bars and punished according to the law.
