With due respect I Smt.Krishna Roy, Daughter of Khitish Roy, wife of Pintu Roy, C/o Sulekha Singh, ward no-47, Police Line, Ram krishna Colony, P.S. Pradhan Nagar, Dist-Darjeeling, would like to draw your kind attention to the following effect that today on 23/12/2022 at about 11.30 am above named 1.Pintu Roy, son of Late Malin Roy,2. Saradhni Roy, wife of Late Malin Roy,3.Nimai Roy (Jamai) and 4.Pemananda Roy (Kaku) came at my. above mentioned resident and say they are here to meet with my daughter Bhagayasree Roy (8 years) but all of sudden they started to using filthy languages towards me without any rhyme or reasons and even assaulted me inflantly in front of my daughter by my aforesaid Pintu Roy, he also tried to disrobe my cloths and tried to molest me by touching me and my body. It is matter of regret to state that I was separate from above named Pintu Roy and his families since 2018 and I am currently working as West Bengal Police Lady Constable at Siliguri Commissionerate and one Divorce application filed in the year 2020 and is pending at Siliguri Court between me and Pintu Roy but even I was separated from him and his families due to their atrocities against me and my daughter, the above named persons tried to threatened me when ever were they meet me and even they went to my daughter's school Sarda Sishu Thritha School at Sevoke Road to threatened my daughter that they will soon capture me and take far away to different city outside the reach of mine. Daughter being aggrieved from such threatening words of their couldn't sleep for countless nights imprinting a sense of fear in her mind. Therefore both me and my daughter are going through mental truma , anxiety, insomnia. Hence in the light of above narrated grievances I request you to look into the matter and to do the need full as per law.
