Sir,

In producing herewith one accused person named Naren Biswakarma (48) S/O- Lt. Binoy Kumar Biswakarma, c/o Suman Saha of Surya Sen Colony, Ward No. 01, near Shiv Mandir, PS Pradhan Nagar, Dist Darjeeling under arrest along with following articles under proper seizure.

1. 18 (Eighteen) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml, Total 10.8 liters)

I, SI Abhishek Theengh of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person named Ashish Mahali (23) S/O- Kartick Mahali of Check Post, Jogi Jhora, Barobag, Joteshwar, PS Falakatta, Dist Alipurduar to the effect that today on 24.12.2022 at 18.15 hrs received a source information that one person named Naren Biswakarma is selling liquor in his house situated at Surya Sen Colony, Ward No. 01, near Shiv Mandir under Pradhan Nagar Police Station without any valid license. Accordingly, I informed the matter to you and as per his kind direction myself along with CV-223 Swapan Chettri, CV-128 Ajay Sahani had been to Siliguri Junction under Pradhan Nagar PS to verify the veracity of the information. On reaching there and as identified by the source it found that one person was selling and storing liquor at his shop. Subsequently, I along with my force cordoned the house and was able to detain the above noted person.


Subsequently on being asked the apprehended person disclosed his name and identity as noted above and stated that he is the owner of the house. Further being searched the above noted seized articles were found in the said house. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 06(six) months for his illegal gain. Then I seized and labeled the above-mentioned liquor under proper seizure list in presence of witnesses and arrested the above-mentioned person Naren Biswakarma (48) S/O- Lt. Binoy Kumar Biswakarma, c/o Suman Saha of Surya Sen Colony, Ward No. 01, near Shiv Mandir, PS Pradhan Nagar, Dist Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 19:15 hrs to 19:55 hrs at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Naren Biswakarma (48) S/O- Lt. Binoy Kumar Biswakarma, c/o Suman Saha of Surya Sen Colony, Ward No. 01, near Shiv Mandir, PS Pradhan Nagar, Dist Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
