Respected Sir,

I, AKASH GAHATRAJ, Son of Late Pran Singh Gahatraj, R/O.Saheb Para, Upper Bagdogra, P.O.& P.S. Bagdogra District Darjeeling. Pin-734014, West Bengal, would like to state that my father left house on 03.12.2022 at about 6:30 P.M. and after about 1 hour when he didn't return home I and my family members tried finding him. On our search I came to know from some local peoples that one unknown person met with an accident near Singhijhora Tea Garden, Bagdogra. After getting the news I and my family members went to Bagdogra police station and from there Bagdogra Police informed me that one two wheelers has hit my father and my father has been admitted at North Bengal Medical College & Hospital for treatment. He was serious. I and my family rushed to North Bengal Medical College & Hospital and found my father undergoing treatment. He was seriously injured. Later my father died on 06.12.2022 at North Bengal Medical College & Hospital. I come to know that one two wheeler bearing WB 74 AN 5704 Hit my father. Due to the said accident my father sustained serious injuries and died. I was late in lodging the FIR as I was busy for my father treatment.

It is requested before you to do the needful and take strict necessary action against the person involved in the said accident so that he can be punished as per law.
