In producing herewith two arrested accused persons namely (i) Dipak Sahani (26) S/O Badal Sahani of Shantinagar, P.O+P.S. Dalkhola, Dist-Uttar Dinajpur and ii) Ranjit Roy (33) S/O Lt. Chandan Roy of Bore Borwa, PO-Babon Gram, PS- Raiganj, Dist-Uttar Dinajpur, (not verified) along with the following seized articles under seizure as per seizure list:

- i) One white coloured Suzuki Ertiga Car bearing Registration No. WB60Y-0677 (Smart Hybrid)
- ii) One Black coloured carry bag containing one transparent plastic pouch containing 650 grams said to be brown sugar marked as Exhibit-A out of which 50 gram taken as sample and marked as Exhibit- A-1
- iii) One blue coloured OPPO smart phone model no- XAYAX3000 & IMEI No. 865931041042797 seized from accused Ranjit Ray
- iv) One black/red coloured iTEL key pad phone bearing IMEI No. 351612471001740 seized from accused Di pak Sahani

I, SI Pradip Kr. Singha of Ashigarh Out Post, Under P.S. Bhaktinagar Siliguri Police Commissionerate do here by lodge this written complaint against (i) Dipak Sahani (26) S/O Badal Sahani of Shantinagar, PO+ PS-Dalkhola, Dist-Uttar Dinajpur. (ii) Ranjit Roy (33) S/O Lt. Chandan Roy of Bore Borwa, PO-Babon Gram PO-Raiganj, Dist-Uttar Dinajpur, to the effect that today on 26.12.2022 at about 13.45 hrs. Received a specific source input that two persons are coming from Malda towards Siliguri via Eastern Bypass (NJP side) with huge quantity of brown Sugar in their white colour Suzuki Ertiga Car bearing Registration No. WB60Y-0677 for selling the same to their customers for their wrongful gain. The matter was diarized vide Ashigarh O.P. GDE No. 628 Dt- 26.12.2022. Accordingly, I informed the matter to the Officer-in-Charge, Ashigarh Out Post and as per his kind direction myself along with ASI Inzamamul Houque, Const-1013 Sanjoy Singha, Const-1181 Bhabesh Ch. Roy all of Ashigarh Out Post, under P.S. Bhaktinagar, left for Baneswar More by govt. vehicle No. WB-42-R-8829, to verify the veracity of the information vide Ashigarh O.P GDE no. 629, Dt- 26.12.2022 and M.C.C No- 1806/22 Date-26.12.2022. At the time of departure from office I took envelope, white paper, sealing wax, gum, seal, weight machine etc. At about 14.05 hrs we arrived at Baneswar More near Chira Mill. On way to Baneswar More I called two independent witness namely i) Abinash Roy S/O Lt. Bipin Roy of North Ektiasal P.S. Bhaktinagar. Dist. Jalpaiguri. ii) Sujit Roy S/O Lt. Satish Ch. Roy of Naresh More, Telipara. P.S. Bhaktinagar. Dist. Jalpaiguri, and informed them about the information in hand and requested them to accompany us to witness for search and seizure if necessary under relevant provision of law. At about 14.25 hrs as spotted by the source, we impounded the vehicle no. WB60Y-0677 and found another person sitting along with the driver, which was matched with our information. Accordingly I detained the said persons and on question they disclosed their name and identity as noted above. I informed them about the information in hand after disclosing our identity, I asked them whether they have any objection to be searched in presence of any Executive Magistrate or Gazetted officer and they agreed to be searched in presence of any Gazetted Officer or any Executive Magistrate. I served them a notice

in accordance with the provisions of law in this regard. Then I send a notice to Shri Narendra Kalikotey ACP SB SPC through special messenger with a request to appear at the spot and remain present as Special Executive Magistrate. After some times at about 15.05 hrs Shri Narendra Kalikotey ACP SB SPC arrived at the spot. I narrated the whole fact to him and disclosed the identity of Shri Narendra Kalijotey ACP SB SPC to the accused persons as Special Executive Magistrate. Under supervision of Shri Narendra Kalikotey ACP SB SPC the above noted accused persons were searched keeping strict regard of their decency. Also searched the said vehicle and as shown and handed over by both the above mentioned accused persons recovered "One Black coloured carry bag containing one transparent plastic pouch containing 650 grams said to be brown sugar from the dais box of the vehicle and marked as Exhibit-A out of which 50 gram taken as sample and marked as Exhibit-A-1.

The accused persons namely (i) Dipak Sahani (26) S/O Badal Sahani of Shantinagar, PO+ PS-Dalkhola, Dist-Uttar Dinajpur and ii) Ranjit Roy (33) S/O Lt. Chandan Roy of Bore Borwa, PO-Babon Gram, PS-Raiganj, Dist-Uttar Dinajpur, confessed in presence of Special Executive Magistrate and other witnesses that as directed by one Rohit Sahani S/O Ramu Sahani of Subash Pally, Paldoria, PS- Dalkhola, Dist- Uttar Dinajpur, they procured the said Brown Sugar from one Raju of Gazol, Malda for selling the same at Siliguri with a view to earn huge money quickly. On being asked they failed to produce any documents or license in support of their possession. Then as per direction of Shri Narendra Kalikotey, ACP SB SPC, I seized, sealed and labelled the said to be Brown Sugar under proper seizure list in presence and duly signed by witnesses under the supervision of Shri Narendra Kalikotey ACP SB SPC. The seizure was made in between 15.25 hrs. to 16.35 hrs. Then I arrested the above noted two accused persons after observing all formalities and disclosing the cause of arrest and issued necessary memo of arrest. The copy of seizure list and memo of arrests have been supplied to the above noted accused persons under receipt. Thus the accused persons violated the terms and condition of N.D.P.S Act. For possessing Brown Sugar without any authority. The videography has been done of whole process by videographer.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons named (i) Dipak Sahani (26) S/O Badal Sahani of Shantinagar, PO-Dalkhola, Dist-Uttar Dinajpur and ii) Ranjit Roy (33) S/O Lt. Chandan Roy of Bore Borwa, PO-Babon Gram, PS- Raiganj, Dist-Uttar Dinajpur iii) Rohit Sahani S/O Ramu Sahani of Subash Pally, Paldoria, PS- Dalkhola, Dist- Uttar Dinajpur, iv) Raju of Gazol, Malda and others, and arrange for its investigation.
