Respected Sir,

I, Dipak Kumar Routh son of Baijnath Routh, resident of Pati Colony, Road No.3, P.O. & P.S. Pradhannagar, Dist. Darjeeling, do hereby lodged this F.I.R. stating that on 25/12/22 at around 9.45 P.M. me and my brother namely Sri Binod Routh son of Baijnath Routh heard loud noises outside our house in front of gate. As we went out we could see 5 persons fighting amongst them I could recognise two persons namely Amit Das son of Arup Das and Ankur Das son of Atup Das both residing at of my locality were fighting and abusing each other in front of our premises. Seeing this, my brother Binod Routh approached them and requested them not to fight in front of our house as it is causing disturbance of peace of the locality they being drawn started assaulting my brother and beating him with Iron Knuckles and he fainted there instantly, for no reason whatsoever, seeing this, I also went to prevent them from hitting my brother but it was of no use.

My Mother named Urmila Routh, my sister name Baby Routh and my Sister-in-law named as Tulsi Routh resident of as mentioned above also came to stop the fight, but they were grievously hurt by both of them as they kicked my Mother in the hip and she fell down unconsciously in the ground, then they caught my sister-in-law with neck and dragged her inside our house and pushed my sister against the wall and she also fell down, they abused all of us verbally using slang languages and assaulted physically to all of them and started giving us threat that they would come back against with more goons. And after that I admitted all my family members to Siliguri District Hospital at around 12.10 A.M. Midnight for medical treatment as they were grievously hurt.
