I, Pritam Kumar Pandey, son of Late Dinesh Pandey, resident of Medical Thiknikata, Post Office- Sushrutanagar Police Station- Matigara, District- Darjeeling, would like to state that I am running a lottery agency under the name and style of "Maa Bhawani Agency" situated at Medical, Thiknikata. Rangapani Road, Post Office- Sushrutanagar Police Station- Matigara, District- Darjeeling and today at about 3.45 p.m. I went to home for taking my lunch after handing over the said shop to my mother namely Shakuntala Devi, aged about 63 years for looking after the said business until I came back after finishing my lunch and its my daily routine whenever I used to go to take my lunch my said mother used to sit and look after my said business. That today between 4.00 to 4.30 p.m. when my mother was present at my said shop two unknown miscreants had came to my shop and pat hands on my mother head and they have some powder in their hand and sniff the said powder to my mother as a result my mother became unconscious and when she gain her consciousness she found that her gold chain of 10 gm alongwith 4 gm locket inside that gold chain amounting to Rs. 85,000/- (Rupees Eighty Five Thousand) only was missing and then she immediately call into my phone number and hearing the same I rushed to the spot. My mother narrated me that at first she felt that the said two unknown miscreants may be my friend as such they first talk quite well and then pat their hands on my head and after that I did not know anything as what had happen to me and when she gained her consciousness she immediately called me. As per my mother said two miscreants is between the age of 30 to 35 years, one guy is very tall and of fair skin man and other is about of 5 feet in height and of fair complexion. I am feeling myself hopeless as the health condition of my mother is deteriorating after such

incident.
