

The undersigned hereby states that as per an enquiry conducted by me, Area Chief Inspector, SMC on 02.11.2022 in the M.R Shop of Sanjay Kumar Gupta a huge stock discrepancies of PDS commodities was found in the concerned shop. As a result departmental proceedings has been drawn against him and he is now suspended as per order of SCF&S, Siliguri vide Memo no.1221/SCF&S/SLG/2022 Dt.28.11.2022.

Now the undersigned wants to file a complaint against Sanjay Kumar Gupta for malpractice conducted by him and for defalcation of PDS items which were allotted to him as a FPS Licence holder through online allocation. He has violated clause 19(13) of PDS control order 2013 and has violated section 7 of the EC Act, 1955(10) of 1955.
