Sir, now it is crystal clear that my said minor daughter has been kidnaped by said Md. Gaddu with the help of his uncle namely Md. Mustaque & others.

So, please take necessary action against said, Md. Gaddu, Md. Mustaque & their associates who are involve in this crime.
