This is to inform you that I Subrata Das S/O- Subal Das residing at 1 No Dabgram, Rabindra Sarani, Vivekananda Street Ward no 23 would like to inform you that yesterday (25.12.2022) at 10:30pm-10:45pm I was on my way towards my home, at Atul Prasad Sarani, Hakimpara ward no 15 **Shiva Saha, Sagar Ghosh (Babin), Bipul Roy (Bittu)** and others stopped me and started abusing me. All of them were intoxicated I avoided them and tried to go away, they started assaulting me physically, they started slapping and punching me. When I started to shout for help, one of them from behind kicked me, I fell from my Scooty and Suddenly they started to beat me with a wooden stick, Though I was unconscious they continuously kicked me, Punched me etc.

Later with the help of local peoples I was taken to the District Hospital and after treatment I informed Local Police Station regarding this matter, Instantly Patrolling Van reached the Location but by the time Police reached they all escaped.
