Sir,

With due respect, I Shri Samir Roy, S/o of Shri Rajkumar Roy, Resident of Shantinagar P.O :- Dabgram P.S :- Bhaktinagar Dist: - Jalpaiguri, would like to inform that on 1-9-2019 one Sri Mohit Chhetri, S/o Shyam Chetri, C/o Naresh Garg, Orchid Residency MN Saha Sarani P.O. & P.S – Pradhan Nagar, Siliguri District – Darjeeling-734003 has visited my house and induced me for financial help in the tune of Rs. 4,00, 000/- (Rs. Four Lac) only as loan for the period of 3 months only on the pleading to repurchasing vehicle HYUNDAI I10 GRAND, bearing registration number WB74AW 8271 from Chandan Kumar Mahato with condition that he will return the said money in the tune of Rs. 4.60. 000/- (Rs. Four lack Sixty Thousand) only within 10th December 2019 and after considering the relation and considering the period of return of the money, I agreed to help him financially as loan with a sum of Rs. 4,00, 000/- (Rs. Four lack) only and on 27-9-2019, I have paid the said money amounting to Rs 4,00,000/- (Rs. Four lack) only to the said Mohit Chhetri and after my repeated request, the said Mohit Chhetri has issued an account payee cheque bearing No – 706860 dated 30-10-2022 drawn with State Bank of India, Mangal Deep Branch, Siliguri for the sum of Rs. 4, 60, 000/- (Rs. Four Lack Sixty Thousand) only and on 31-10-2022 when I produced his aforesaid said cheque before my banker State Bank of India, Siliguri Branch, Siliguri for encashment, the said cheque was dishonored due to Insufficient Fund in his account.

Sir, though he repurchased the said vehicle but has cheated my money and still has not returned the same to me for his illegal gain and wrongful loss to me. On trust that the said Mohit Chhetri shall return my money within 3 month but he did not complied his words and has issued cheque in my name but the said cheque was also bounced by his banker due to insufficient fund and in such a way I have been cheated by the said Mohit Chhetri.

So, you are hereby requested to investigate the matter and take necessary legal action against him for the interest of justice.
