Sundar Thapa of Village: Pipli Dara ,Gielle Tea Garden , PO+PS Rangli rangliot, Dist:Darjeeling would like to inform you that my only son Skanda Thapa (36yrs) of Village : Pipli Dara ,Gielle Tea Garden ,PO+PS Rangli rangli OT use to work as teacher of one private school at Bihar since 2years and yesterday i.e., on 27/12/2022 he was coming to home as his school had granted him 04 days leave, but while returning home one unfortunate incident occurred in between 20:00hrs to 20:30hrs at Shivamdir Medical More which falls under the jurisdiction of Matigara PS. My son Skanda Thapa was trying to cross the road at the Zebra crossing of Medical more crossing when one white coloured SUV car plying towards Siliguri which was coming in high speed and was driving negligently dashed my son in the middle of road as a result of which he received greivous head injury ,my son Skanda Thapa was taken NBMCH by the police van where the attending doctor declared him brought dead .

So I pray before you to kindly lodge FIR against the driver of this white coloured SUV car who dashed my son and due to his rash and negligent driving and made us suffer from this irreparable loss. I would be highly obliged if you kindly do the needful and take immediate and strict action against this negligent driver.
