Even after our several efforts of fulfilling their insaliable demands we failed to restore my fruitful conjugal life. Our Ward Councillor and Mahila Samiti also intervened into this matter and tried to settle the disputes but no suitable result

4. That I came to know after two months of our marriage that my husband is having an extra-marital affair with another woman and it is supported by my aforementioned In-laws.

Received on 28/12/22 at 18:45 hrs. vide BUN PS GDE No-1978 and started Bhaktinagar PS case No-1378/22 date 28/12/22 u/s-498A/323/325/307/34 IPC r/w Sec. 3/4 of D.P Act. ASI Khogendra Ch. Das will investigate the case.

That on 26.12.2022 at about 4:00 A.M. I found my husband was talking with another woman and on seeing when I started to protest upon my husband, he and my In-laws became furious and they started to assault me by holding my hair-lock with fists and blows and also with iron-pipe. My said mother-in-law and Elder-In-law tried to kill me by Strangulation as a result I lost my consciousness. After 3 to 4 hours when I regained my consciousness I found that I was lying on floor. I then rang my brother and informed about all these.

6. That on 27.12.2022 at 1:00 P.M I was rescued by father and my relatives and was then admitted to Siliguri Civil Hospital. Now, I am under treatment.

I therefore, request you to kindly take necessary legal steps against the aforesaid culprits and for the end of Justice.

Sir,

I, URMILA DEVI (ROY), wife of Rakesh Kumar Roy, resident of Prakash Nagar, W/NO. 43 under S.M.C., P.O. Sevoke Road, P.S. Bhaktinagar, Dist. Jalpaiguri, begs to state that as follows:-

1. That Rakesh Kumar Roy, son of Satendar Roy, of above-mentioned residence, is my legally married husband. A Hindu marriage was solemnized between us on 27.04.2022 at my father's house at Vid. Arna baropur, P.O. Arna, P.S. Mashrakh, Dist. Chapra (Bihar), 841417.
2. That since our marriage my aforesaid husband alongwith my In-laws namely (i) SATENDAR ROY (father-in-law), (ii) LAXMI DEVI (mother-in-law), (iii) MUKESH ROY (Brother-in-law), (iv) KABITA DEVI, w/o. Saitesh Roy (Elder Sister-in-law), (v) NISHA KUMARI (Younger Sister-in-law), (vi) SAILESH ROY (Nandoi), and (vii) SUBHANTI DEVI (DEYADIN), started to torture me physically and mentally in petty matters. After two months of our marriage my husband and all my aforesaid In-laws started to demand Rs. 5,00,000/- (Rupees five lakhs) only from me and my father. On our refusal they all aggravated their vicious torture upon me as a result I use to receive several injuries on my person.
3. That due to their demands my father was pressurized to give Rs. 2,40,000/- (Rupees two lakhs forty thousand) to my husband for the sake of our happy conjugal life but in vain.
