I, Md Azharuddin, Son of Sk Rajab Ali, J.E.(E) Gr-II & SM Power House CCC, empowered by The Electricity Act 2003 amended on 2007 of India do here by lodge this complain for Damage of Property of WBSEDCL near Industrial Estate, Sevoke Road, Siliguri, Dist Jalpaiguri, P.S Bhaktinagar, Pin-734001 by vehicle no BR 01 GK2467 of SBA Logistic(Ph No-7677256770), as reported from site. An information was received by the local people regarding a vehicle damaging our infrastructure on 26.12.2022 at 11:15 PM. The LT Mobile maintenance van of PHCCC was sent to site and the report was confirmed by the workers of the Maintenance van. As reported from site on 26.12.2022 at around 11:15 PM the vehicle having vehicle no BR 01 GK2467 had hit the LTOH wire damaging the properties of WBSEDCL. Photographs of the Incidents were taken and are attached here with. It was found that total 3 span of LTOH wire were broken causing a Financial Loss of WBSEDCL of around Rs 16755/- (Rupees Sixteen Thousand Seven Hundred Fifty Five Only) and the quotation was received by SBA Logistic on 27.12.2022. They were requested to pay the same as early as possible so that no complain would be lodged from our end but till now no payment has been made from their end so I want to lodge the complain now.

Thus you are requested to kindly initiate an investigation against the owner of the vehicle no. BR 01 GK2467 under Section 139 of the Indian Electricity act 2003 amended on 2007.
