In producing herewith the following seized articles as per proper seizure list viz: (1) 21 (Twenty one) bottles of Himalayan Gold 60up country spirit containing 650 ML which was kept in one big nylon hand bag at the street shop of one Ashok Singh and lodged a written complaint against one Ashok Singh-45yrs s/o Lt Jogindar Singh of Gandhinagar ward no-43 PS Bhaktinagar Dist Jalpaiguri to the effect that to the effect that on 29.12.22 at 20.05 hrs received a source information from Prakashnagar under Bhaktinagar PS that one person namely Ashok Singh has gathered huge quantity of liquor in his street shop at Prakashnagar Biswanath More for selling the same in the open market for his wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No-2028 dated 29.12.22. As per your kind instruction myself along with force proceeded to the PO to work out the information.
