Dear Sir,

In reference to the subjected matter, this is to inform you that 03 (three) No. 300A, 415V Porcelain Cut-outs were found missing from the LT Kiosk fitted with 100kVA Distribution Transformer structure situated at Suryanagar (near Bhajan Ghosh More) (DTR Code: GE04D). The incident came to the notice of this office while our LT Mobile Van attended the location getting a complain of 'No Power' (Docket No.: 53670763) at around 08:00 am in the morning today (30.12.2022) & as gathered from the site, this incident took place in the early morning around 04:00 am on 30.12.2022. Moreover, it resulted to 'No Power' situation at the nearby areas causing inconvenience to the public & WBSEDCL suffered a loss to the tune of Rs. 10,000.00 (approx.) in this incident. Moreover, we have already temporarily restored power to the surrounding areas.

This is for your kind information & further necessary action please treating this letter as official correspondence regarding the matter.
