In producing herewith one arrested accused person namely Jayanta Roy 40yrs s/o Late Biki Roy of Bidhan Market Auto Stand near Kanchan Junga Lodge Ward NO - 11 PS, Siliguri Dist, Darjeeling along with seized articles viz,

- 1] 13 (Thirteen) Bottles of Country Spirit styled as Himalayan Gold 60 UP of 600 ml each, MRP Rs. 120/- Marked as exhibit - A, out of one bottle randomly taken as sample for examination as sample.  
Marked as exhibit - A-1
- 2] One Nylon printed Bag which used for carrying the seized articles SL. No. 1.

I, ASI Biswajit Saha of Panitanki TOP under Siliguri PS, do hereby lodge a written complaint against the above noted accused person to the effect that on 30.12.2022 at 18.45 hrs received a secret source information that one person was selling huge quantity of bottled country spirit through Bidhan Market Auto Stand near Kanchan Junga Lodge from his house Ward No - 11, PS, Siliguri if come immediate he has been arrested. Accordingly the information was diarized vide Panitanki TOP GDE No. 682 dated 30.12.2022 and informed to O.C, Panitanki TOP and thereafter as per his direction, I along with K-28 evening van party ASI Biswajit Ghosh, C/576 Binoy Ch Roy and C/ 1036 Gopal Srivastav left from Panitanki TOP to work out the information. On arrival at Bidhan Market Auto Stand near Kanchan Junga Lodge at around 19.00 hrs being pointed out by the source one house, found that one person is selling of huge quantity of country spirit. We intercepted the person on interrogation he disclosed his identity as Jayanta Roy 40yrs s/o Late Biki Roy of Bidhan Market Auto Stand near Kanchan Junga Lodge Ward No - 11 PS, Siliguri Dist, Darjeeling on search his house in presence of witnesses huge quantity of illicit liquors have been recovered. On interrogation the accused failed to produce any valid documents/license in support of the same and stated that he sale the same to the local public at Bidhan Market adjacent area illegally with a view to earn huge money for his lively hood. Accordingly, I seized 13 (Thirteen) Bottles of Country Spirit styled as Himalayan Gold 60 UP of 600 ml each, MRP Rs. 120/- and 2) One Nylon printed Bag which used for carrying the seized articles SL. No. 1 under proper seizure list and labeled the same in presence of witnesses and duly signed by them and also by the accused person. The seizure was made between 19.10 hrs. to 19.40 hrs. I then arrested the accused person u/s 41 Cr.P.C. after explaining charge against him. The local public was also annoyed with him because of his this kind of illegal activities. As such there was no scope to serve Notice u/s 41A of Cr.P.C.

Hence, under the above noted circumstances I am submitting this written complaint against the above accused person namely Jayanta Roy 40yrs s/o Late Biki Roy of Bidhan Market Auto Stand near Kanchan Junga Lodge Ward NO - 11 PS, Siliguri Dist, Darjeeling for starting a specific case under proper section of Law and to arrange for its investigation.
